By utilizing this multiplayer modification, you agree to comply with the terms and conditions outlined herein.

§ 1. **Game Ownership:** Users must possess a legitimate copy of Grand Theft Auto V on PC to utilize alt:V.

§ 2. **As-Is Provision:** alt:V is provided "as is," without any warranty of any kind, express or implied.

§ 3. **Liability:** The altMP Team disclaims all liability for damages arising from the use or misuse of alt:V.
