1. General

(a) The software (including Boot ROM code and other embedded software), documentation, interfaces, content, fonts and any data that came with your Apple TV, whether on disk, in read only memory, on any other media or in any other form (collectively the “Apple Software”) are licensed, not sold, to you by Apple Inc. (“Apple”) for use only under the terms of this License. Apple and/or Apple’s licensor(s) retain ownership of the Apple Software itself and reserve all rights not expressly granted to you.

(b) Apple, at its discretion, may make available future updates to the Apple Software for your Apple TV. The Apple Software updates, if any, may not necessarily include all existing software features or new features that Apple releases for newer or other models of Apple TV. The terms of this License will govern any software upgrades provided by Apple that replace and/or supplement the original Apple Software on your Apple TV, unless such upgrade is accompanied by a separate license in which case the terms of that license will govern.

2. Permitted License Uses and Restrictions

(a) Subject to the terms and conditions of this License, you are granted a limited non-exclusive license to use the Apple Software on a single Apple-branded Apple TV. You agree not to install, use or run the Apple Software on any non-Apple-branded device, or to enable others to do so. This License does not allow the Apple Software to exist on more than one device at a time, and you may not make the Apple Software available over a network where it could be used by multiple devices or multiple computers at the same time.
