## Apple Watch Hermès Info

### Apple Watch User Guide

Review the Apple Watch User Guide before using Apple Watch. Go to [help.apple.com/watch](http://help.apple.com/watch) to download the ePub version from the iBooks Store (where available), or open the Apple Watch app on iPhone and tap My Watch, then go to General > About > View the Apple Watch User Guide. Retain documentation for future reference.

### Safety and Handling

See "Safety, Handling, and Support" in the Apple Watch User Guide. Apple Watch, some of the bands, and the Apple Watch Magnetic Charging Cable contain magnets. Apple Watch, the heart rate sensor, and the included Apple Watch apps are not medical devices and are intended for fitness purposes only.

### Exposure to Radio Frequency Energy

### Battery

The lithium-ion battery in Apple Watch should be serviced by Apple or an authorized service provider. You may receive a replacement Apple Watch when ordering battery service. Batteries must be recycled or disposed of separately from household waste. ### Avoiding Hearing Damage

### Apple Two-Year Limited Warranty Summary
