We provide scientific information and experiential learning experiences to community leaders, citizens, and children. GETTING DOWN TO BUSINESS NATIONAL ESTUARINE RESEARCH RESERVE SYSTEM

Who, What, and Why

The reserve system comprises 30 reserves, over 1.4 million acres of protected lands and waters, and hundreds of people who care for and study these places. Each site represents the unique attributes of estuary types in their region, allowing our reserves to therefore share information across the nation with those who have similar systems and communities.

The system was established by the Coastal Zone Management Act of 1972. The reserves operate through a partnership program between NOAA and the coastal states. NOAA and the states work collaboratively to develop priorities and programs that are responsive to community needs. Alongside NOAA and the states is the National Estuarine Research Reserve Association, or NERRA, our non-profit that supports outreach, educates the public and Congress, and advocates for funding and the work we do. NERRA also leads the Friends and Foundation Network which is composed of individual reserve's nonprofit friends and foundation groups.

We aim to engage a wide diversity of people and knowledge to address the system's priority issues of climate and environmental change, water quality and quantity, and habitat protection. Each reserve also conducts stewardship, research, education, and training programs to inform stewardship and increase the effective management of these special places.

Mission and Vision

The system's vision is stated as 'resilient estuaries and coastal watersheds where human and natural communities thrive.' To meet this vision, the research reserves constantly strive forward under this mission statement: 'to practice and promote stewardship of coasts and estuaries through innovative research, education, and training using a place-based system of protected areas.

Pillars of Communication

We are places. Research reserves ensure the protection of representative estuaries across the nation as places dedicated to estuarine science, education, and stewardship.

We do work that is locally relevant. Each reserve in the national system is a community hub for integrated approaches that bring together science, stewardship, and education to effect positive change in their community's most pressing coastal issues.

We have a national impact. We work together as a system to deliver science and education programs with local, regional, national, and international impact.

We study how estuaries work and how they are changing. Our science, data, and maps are applied to inform decisions critical to maintaining healthy estuaries, watersheds, and coastal communities. Our monitoring programs make us sentinels for estuarine change across the nation.



This program is founded on a partnership that extends to every aspect of our operation — locally, regionally, and nationally. NOAA, the states, and NERAA (National Estuarine Research Reserve Association) work hand in hand to guide and nurture the system and its work.

Each reserve has a multi-disciplinary staff that serve core functions of management, stewardship, research, education, and technical service to communities. NOAA's Office for Coastal Management also has a cadre of multi-disciplinary staff to support these functions, lead collaborative program development and evaluation, and enable coordination within regions and across reserves. And finally, NERRA has a staff to lead the Friends and Foundation Network and support the work of the system. There is a strong tie among all of these staff, who work to row in the same direction and support each other.

Helping to guide our system into the future is the strategic committee, a body of twelve representatives from the system who come together to update the systems' strategic plan, make recommendations for national products, and create opportunities to vision forward. Additionally, the system employs a multitude of topic specific workgroups bringing staff from across reserves and functions together to guide actions forward. The system aims to cross pollinate in as many ways as possible!

General roles for NOAA, the states, and NERRA are summarized below.

NOAA

Program Coordinators

- Provide leadership to galvanize and enable strategic visioning
- Provide coordination and support for key functions of research, education, stewardship, management, and technical service and training
- Collaboratively develop program guidance, coordinate advisory bodies to support program adaptation, and oversee funding

Reserve Liaisons

- Provide support and connection to resources for reserve program implementation
- Support development of management plans, conduct program evaluations, administer cooperative funding agreements, and support technical service
- Connect reserves to NOAA resources and share lessons learned across reserve system

Subject Matter and Program Liaisons

- Provide leadership and support for Bipartisan Infrastructure Law and Inflation Reduction Act
- Support key functions and programs such as communications, geospatial, and learning services programs, as well as product development
- Lead initiatives to improve diversity, equity, inclusion, justice and access, as well as human dimensions



States

Reserve Program Coordinators and Staff

- Work collaboratively to implement research, education, stewardship, and training programs to meet the needs of diverse communities
- Share local innovations with other reserves
- Lead conservation and restoration efforts to protect the reserve's integrity and longevity

Fellows: Davidson, Coastal Management, and Digital Coast

- Margaret A. Davidson Fellows conduct multi-disciplinary research projects and support reserve activities using their expertise
- Digital Coast Fellows support specific reserve system projects on priority issues
- Coastal Management Fellows support coastal management projects within states and offer transferable information across the system

NERRA


- Advocates for reserve system programs and funding to Congress
- Leads the Friends and Foundation Network and coordinates communication across reserve friend groups
- Educates a wide variety of audiences about the value of the system and its impacts

Friends and Foundation Network

- Supports project work at the reserves
- Advocates for the program locally and nationally
- Educates local community members about their reserve

Under the Coastal Zone Management Act, Congress annually provides appropriations to support the National Estuarine Research Reserve System through two funding lines.

- Operations, research, and facilities (ORF)
- Procurement, acquisition, and construction (PAC)

Operations, Research, and Facilities

This funding line is dedicated to supporting the annual operation of the system. NERRA advocates for funding to Congress, NOAA develops guidance and executes funding, and the states develop annual cooperative agreements that guide funding implementation. These funds are awarded noncompetitively and the states are required to match 30 percent of the total award. Funding goes toward individual reserves as well as competitive research programs, the development of new reserves, support functions for the system, and NERRA. Typical allocations are shown below.

- Operations for 30 reserves
- Margaret A. Davidson Fellowship Program
- Science Collaborative Program
- Centralized Data Management Office
- National Estuarine Research Reserve Association
- Support of new reserve designations
- National products and program support


Procurement, Acquisition, and Construction

This funding line supports reserve facility and campus infrastructure needs, small scale restoration projects, green infrastructure projects, and land acquisition used to expand reserve sites. Funding may be used for small scale projects such as docks, boardwalks, and exhibits, as well as large projects that include research labs and headquarters facilities. Reserves compete for these funds; projects selected are identified in reserve management plans. States also provide matching funds for these projects: 30 percent for construction and 50 percent for land acquisition. NOAA has also been able to use this funding line to support equipment purchases for monitoring programs and operational needs.

Bipartisan Infrastructure Law and Inflation Reduction Act

Under this legislation, NOAA provides noncompetitive and competitive funding for climate resilience activities, restoration, and land acquisition.





How are research reserve sites chosen?

A biogeographic classification scheme based on regional variations in the nation's coastal zone was developed to ensure that the National Estuarine Research Reserve System includes at least one site from each region. This approach, which is outlined in the program's regulations, is used to ensure that sites reflect the wide range of estuarine types within the United States. This representation lets the work accomplished to be more readily shared with communities with similar systems.
