

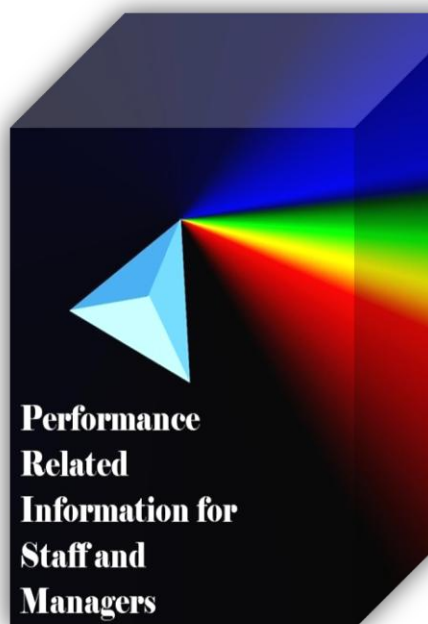

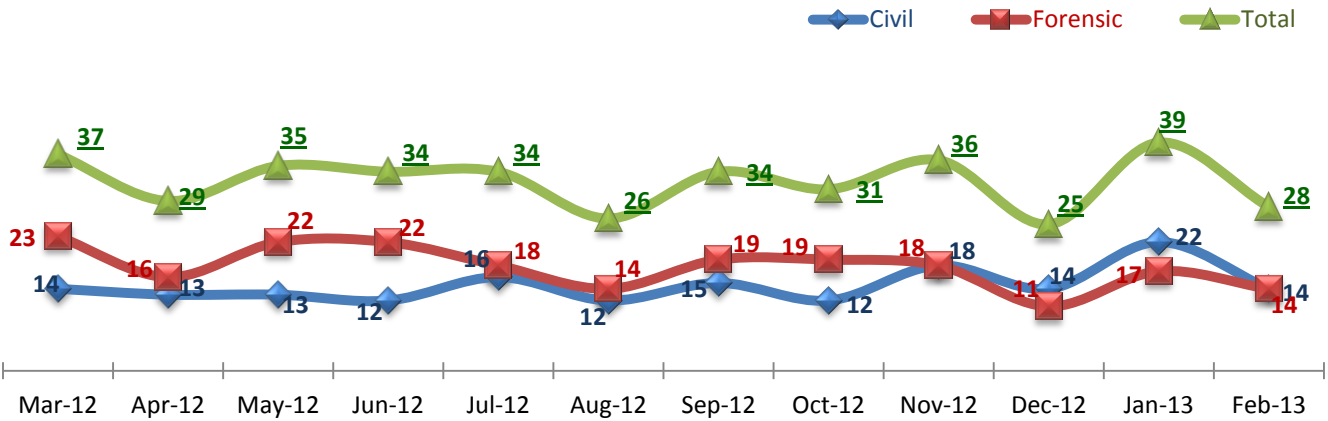

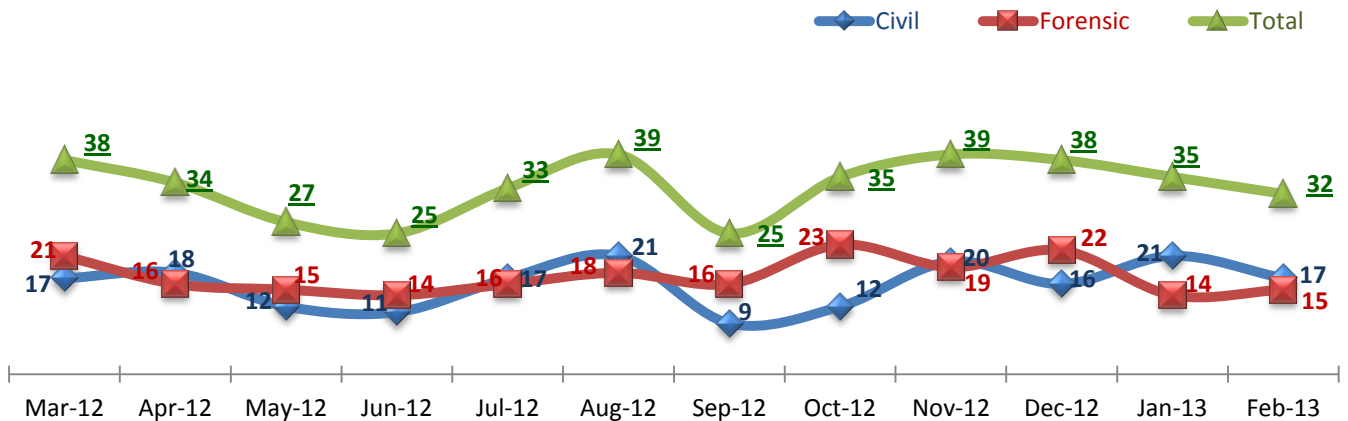

1. Admissions to SEH



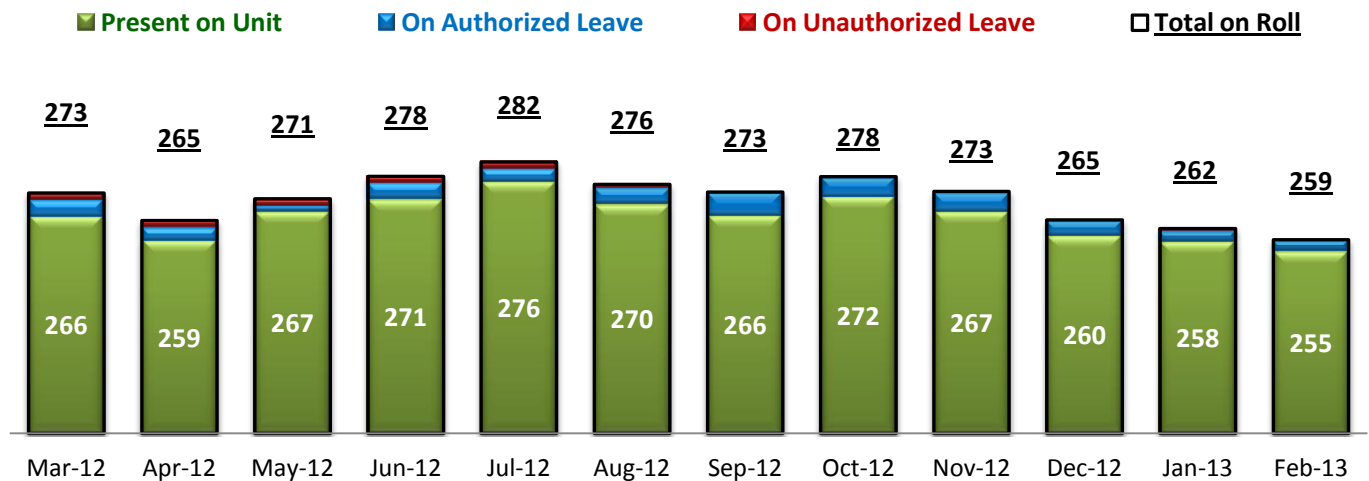

2. Discharges from SEH



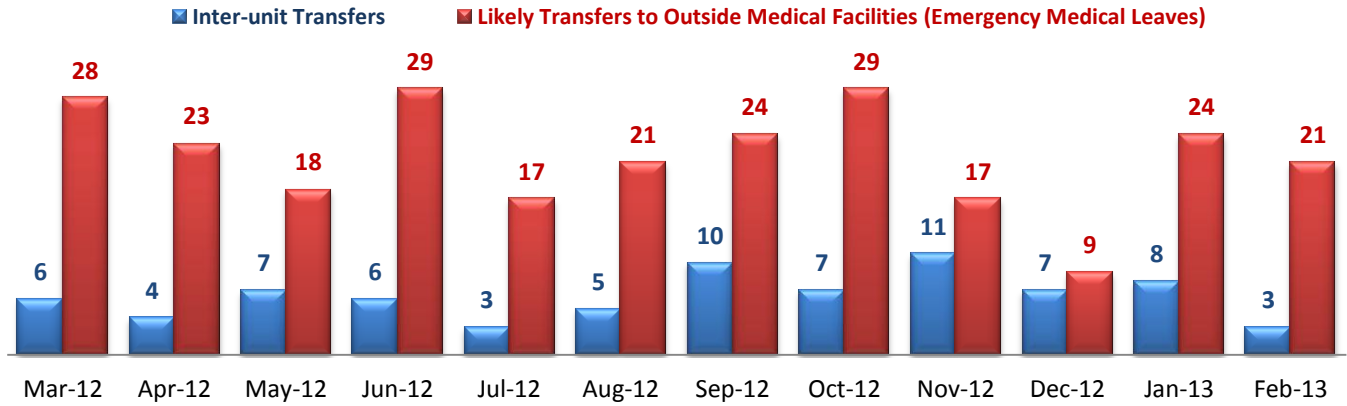

3. Average Daily Census



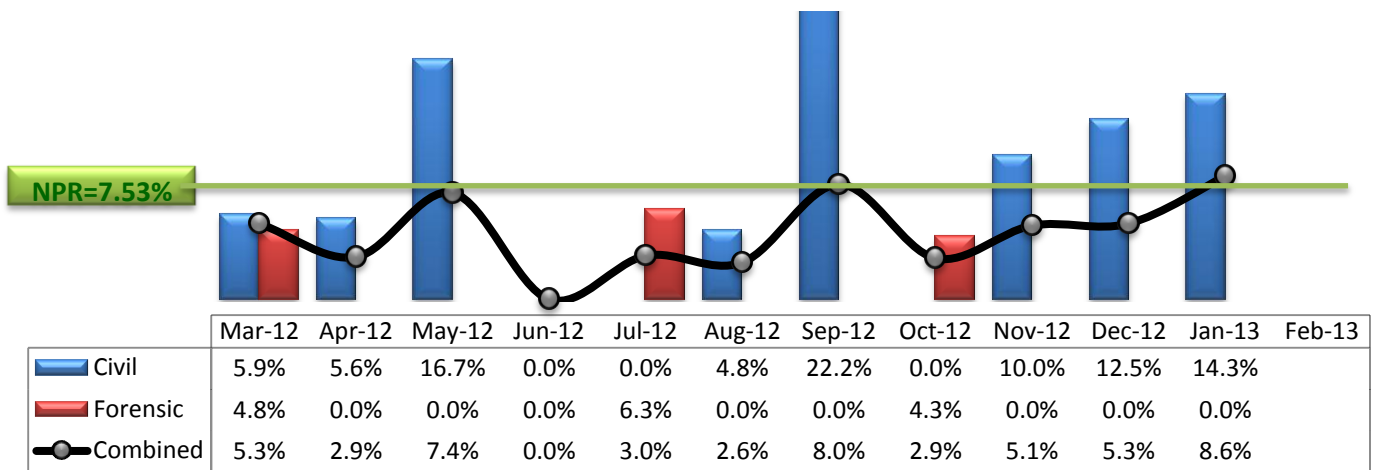

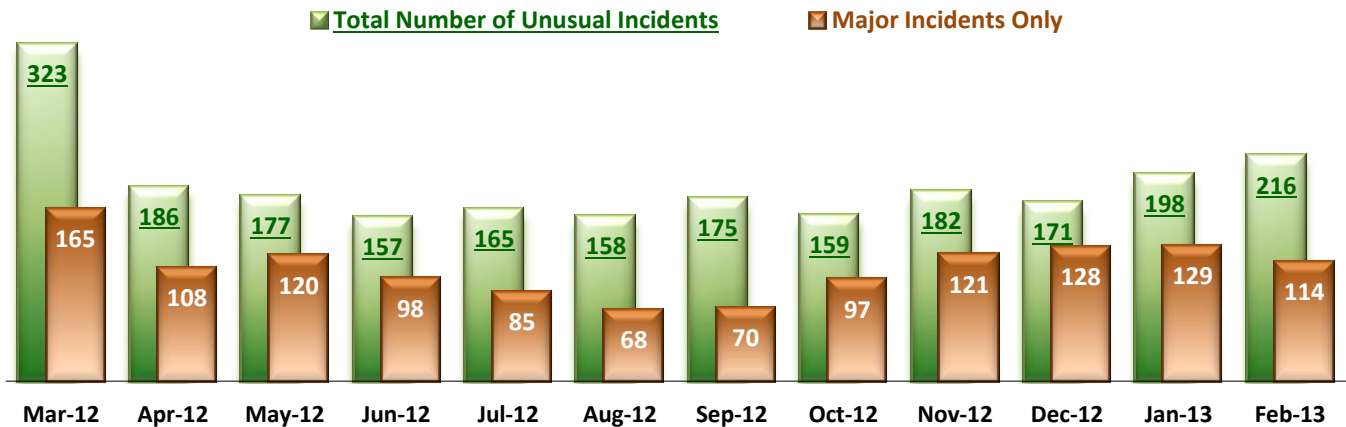
5. 30-Day Readmission Rate

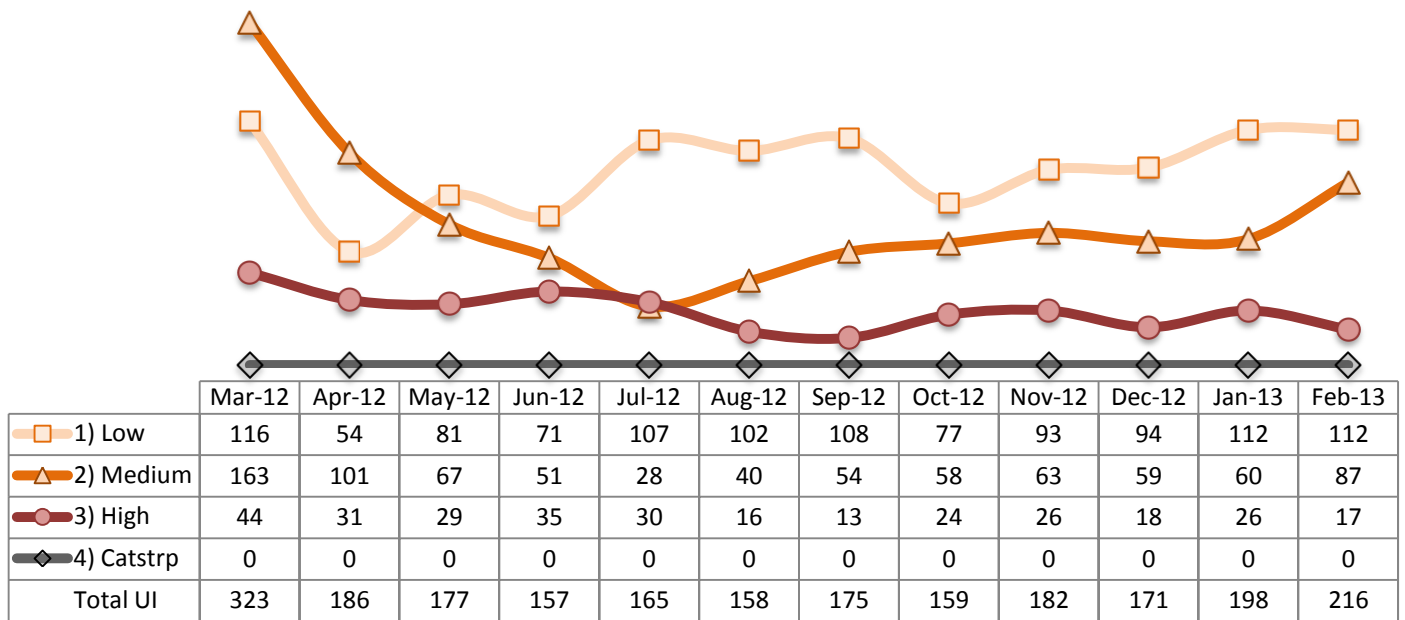

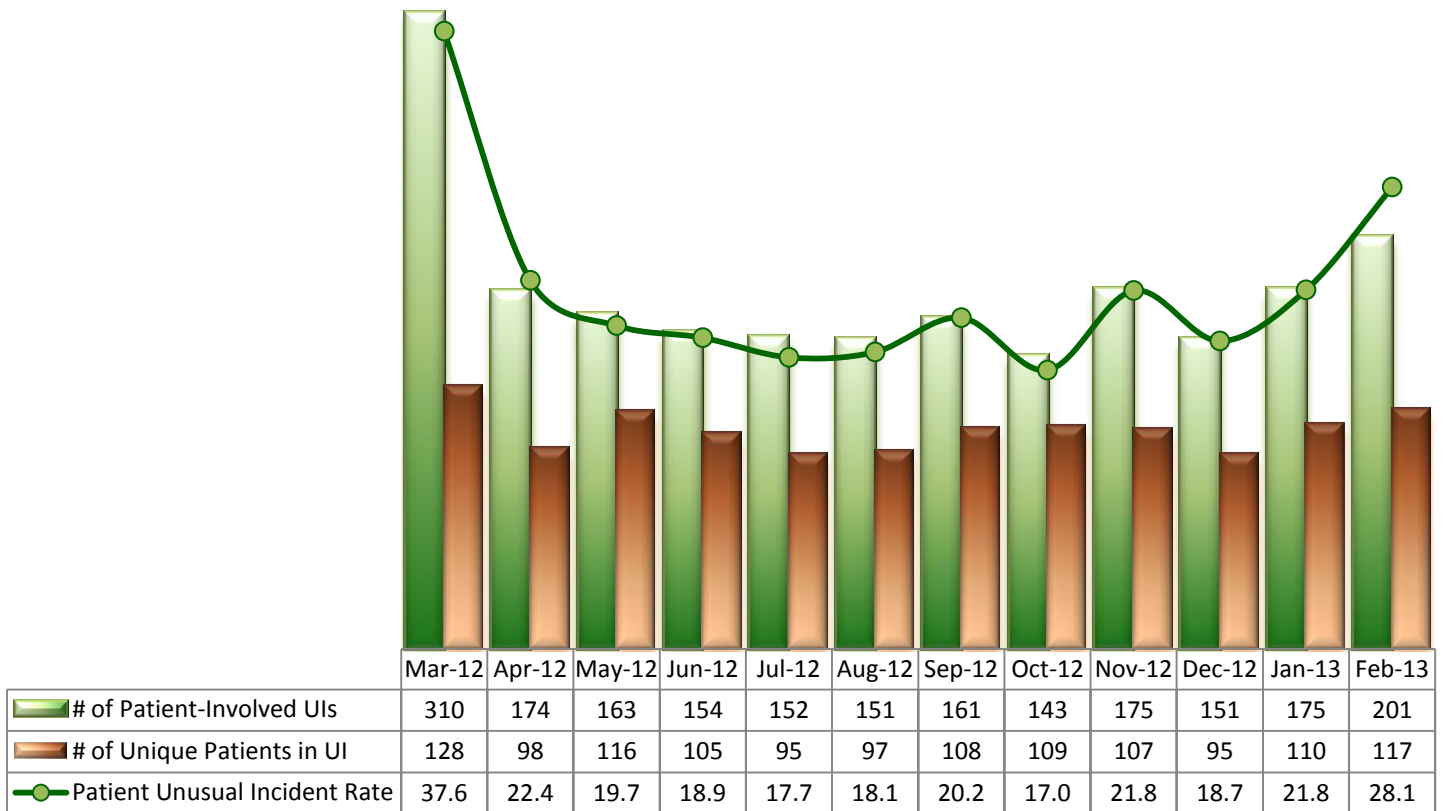

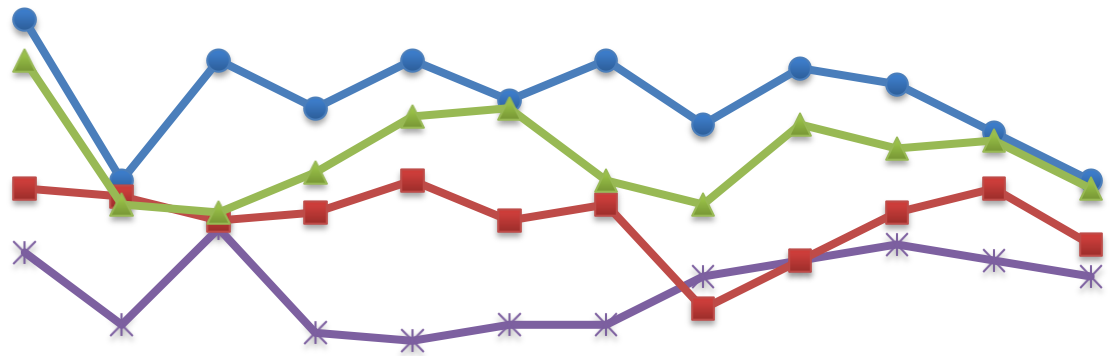


8. Patient-Involved Unusual Incidents

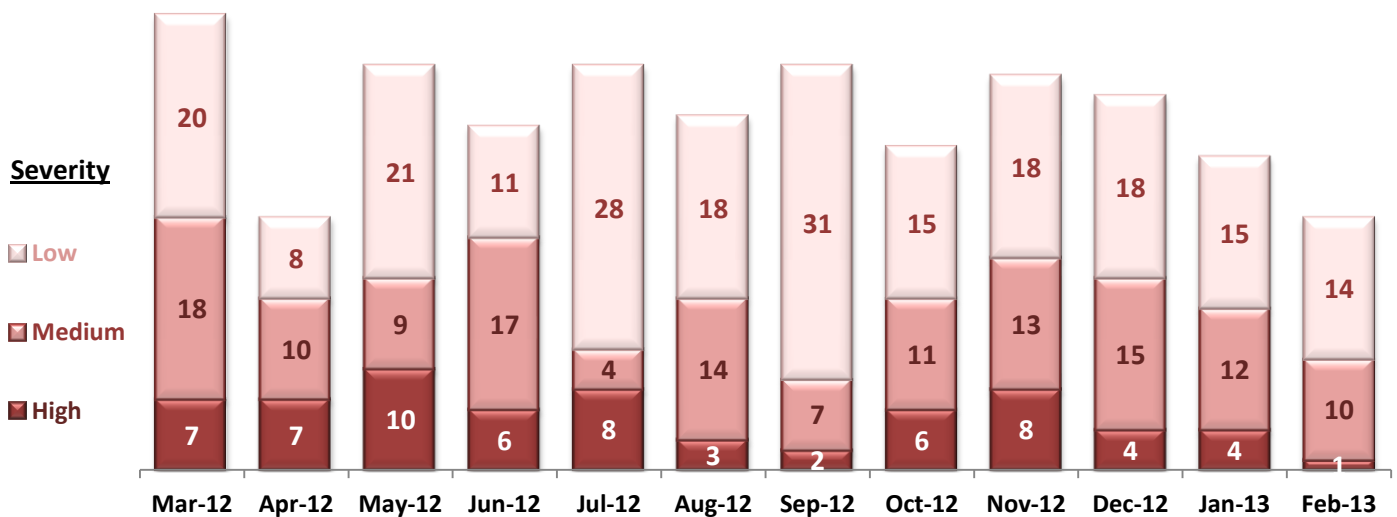

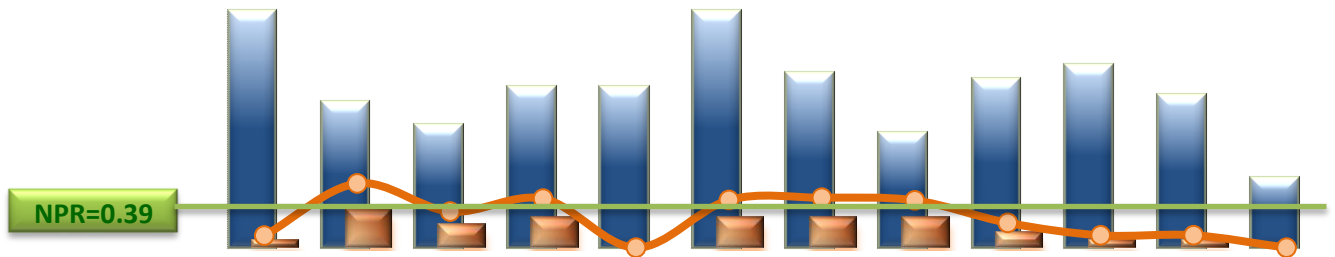

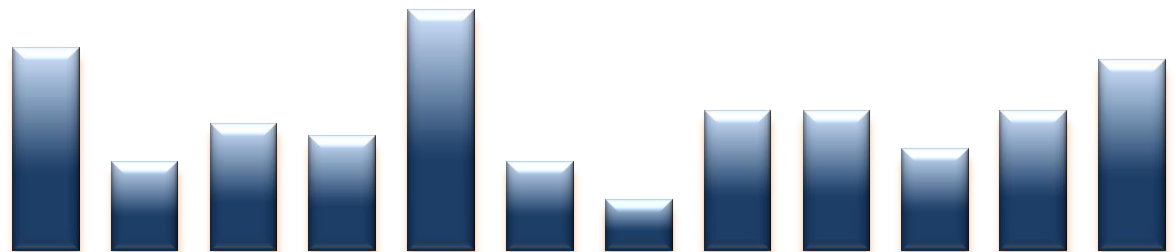

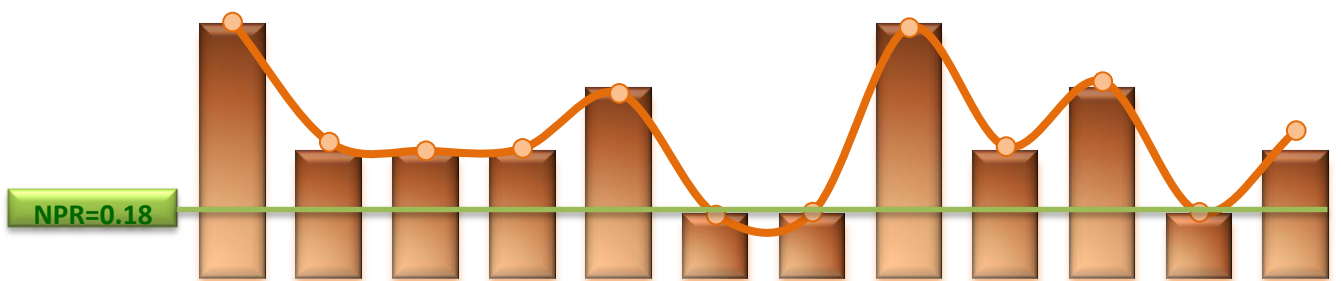

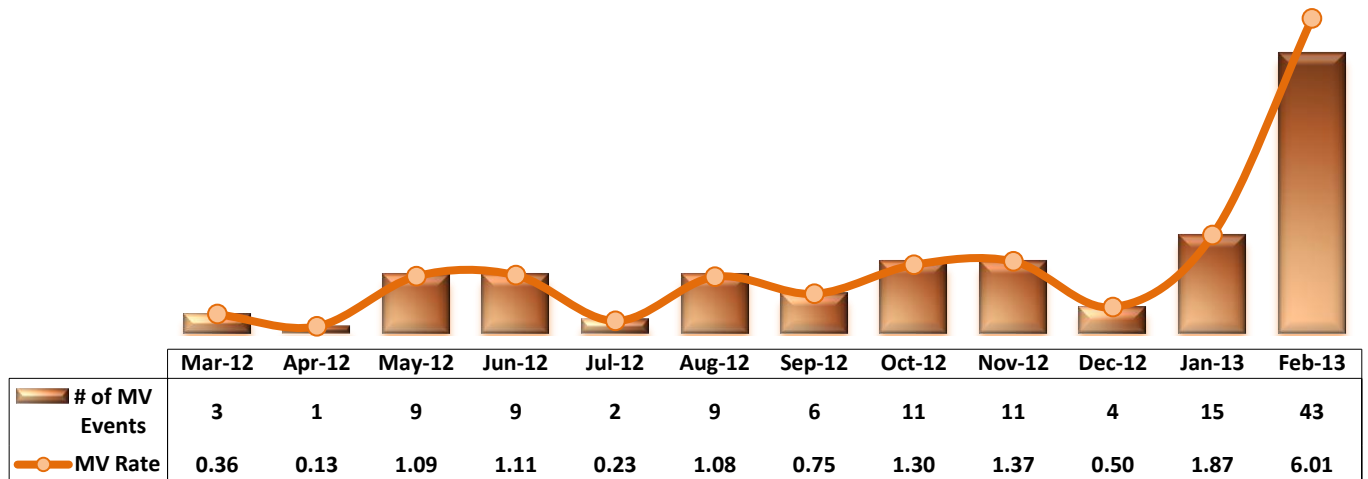

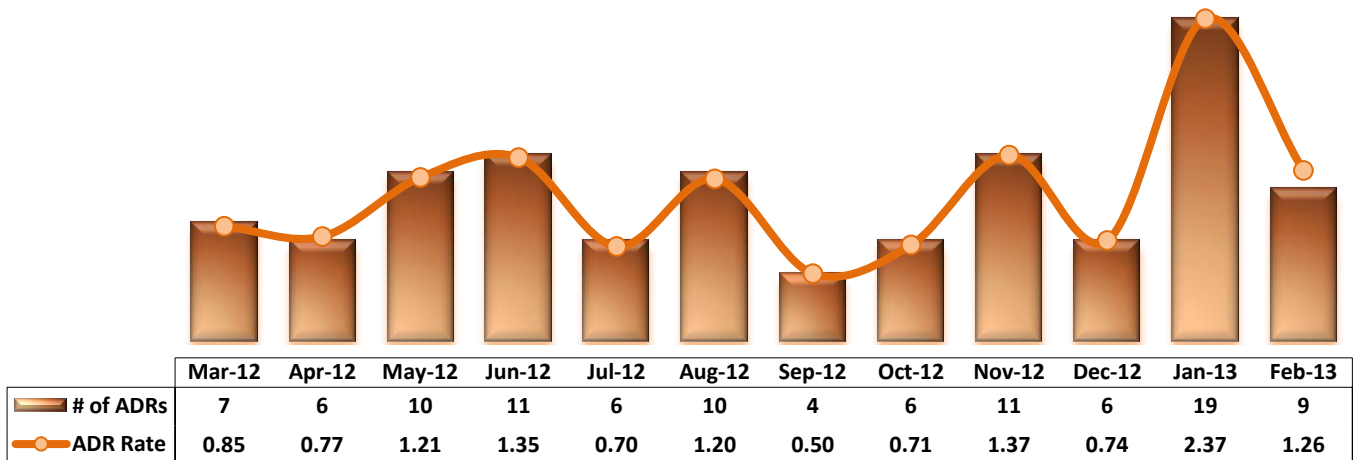

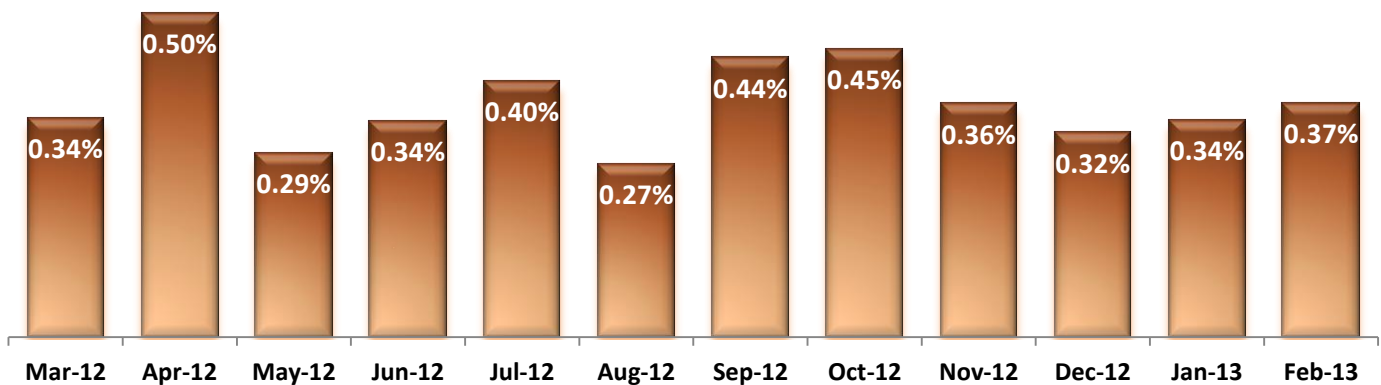

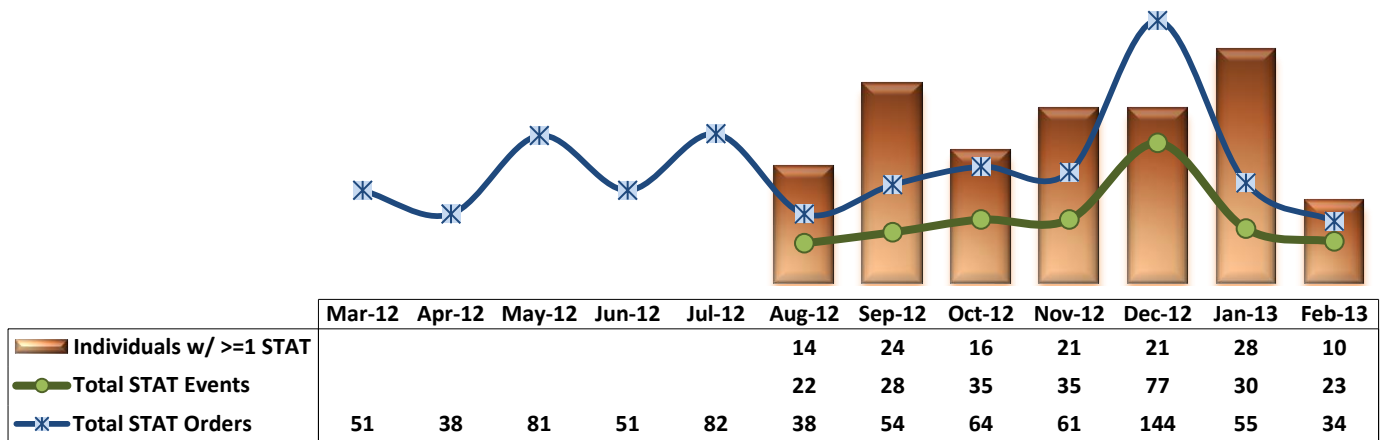

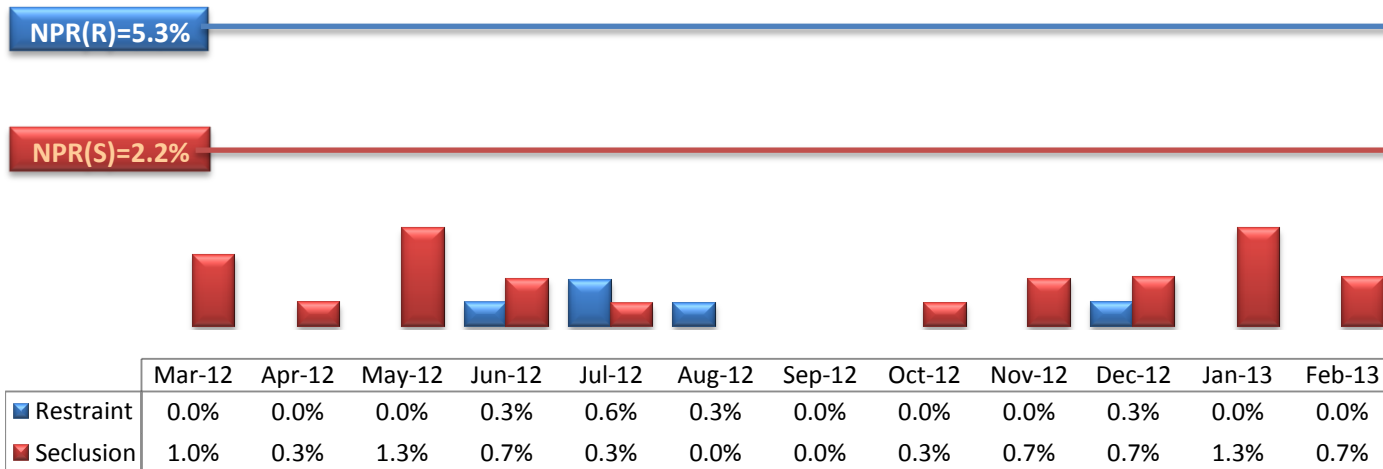
16. Percent of Missing Documentation on Med-Administration

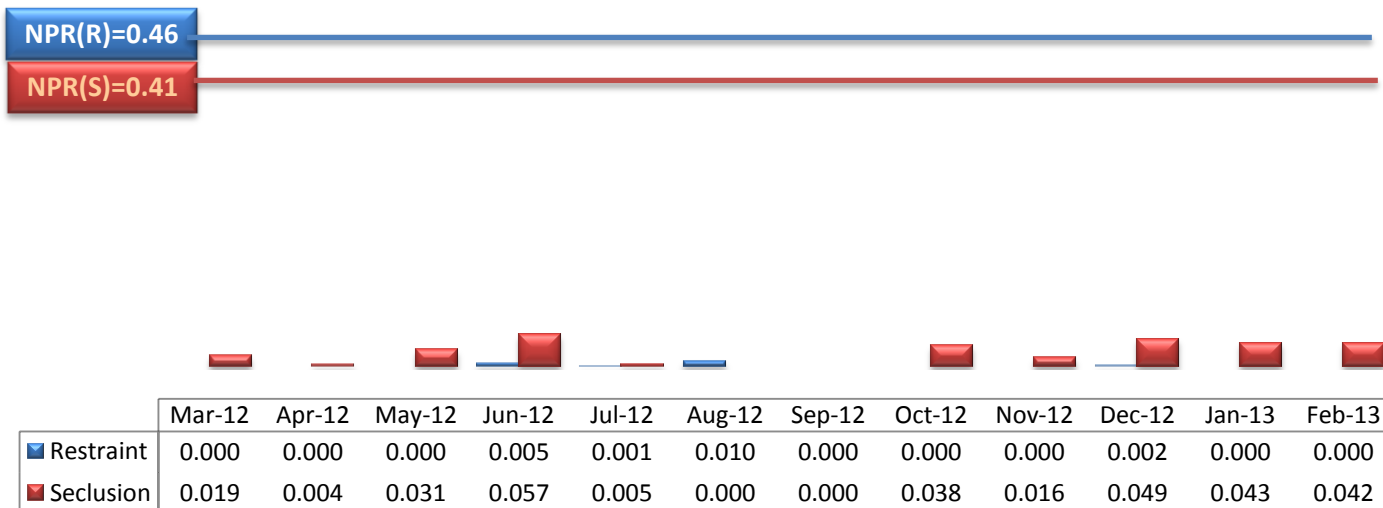


18. Percent of Patients Restrained or Secluded

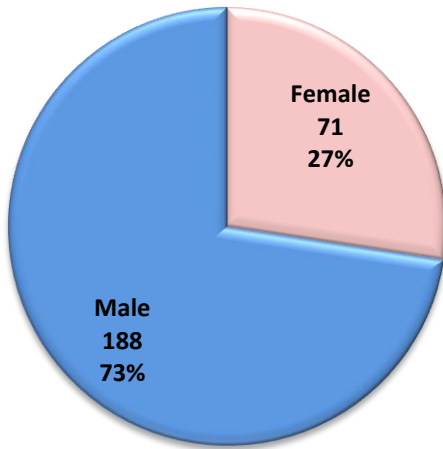

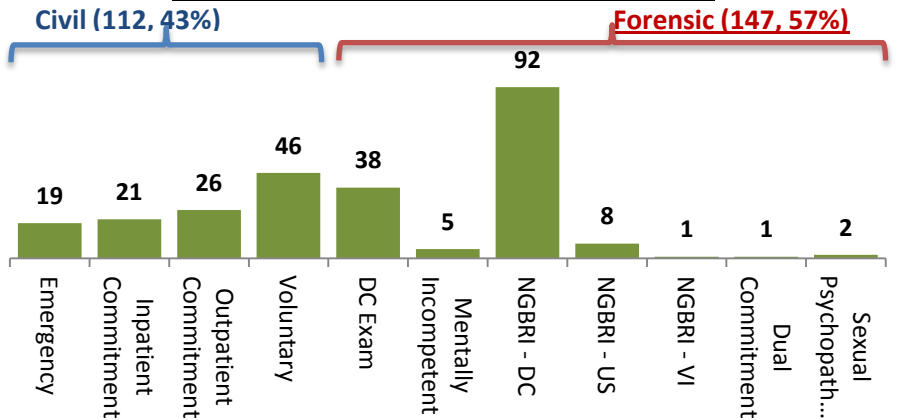

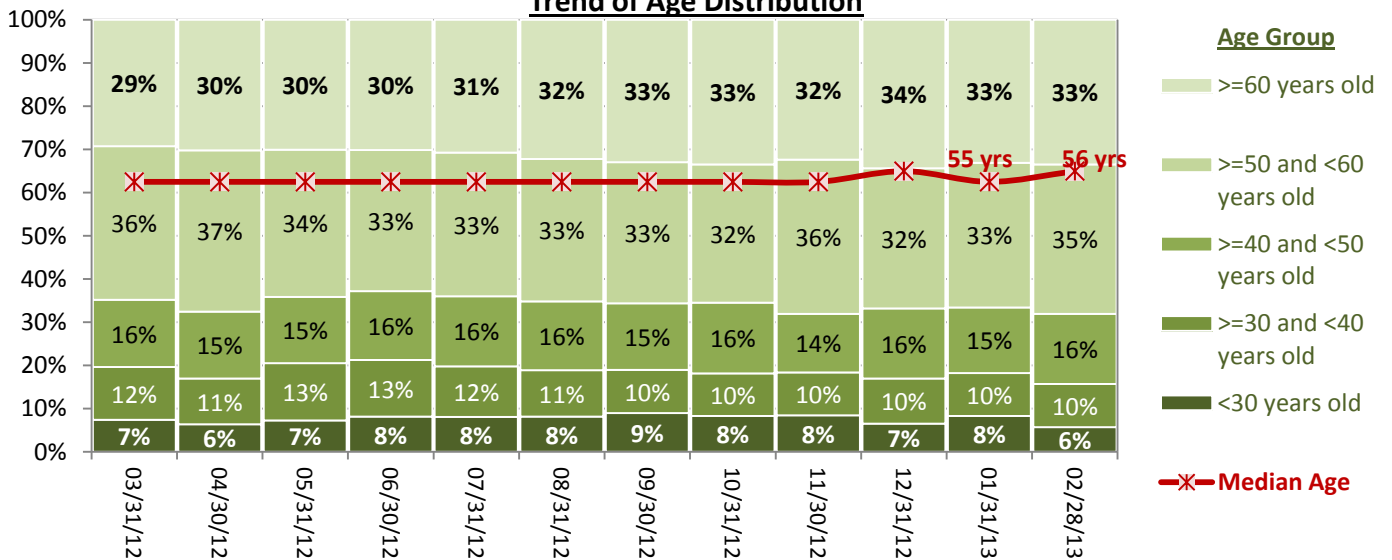
Gender Distribution (2/28/13)



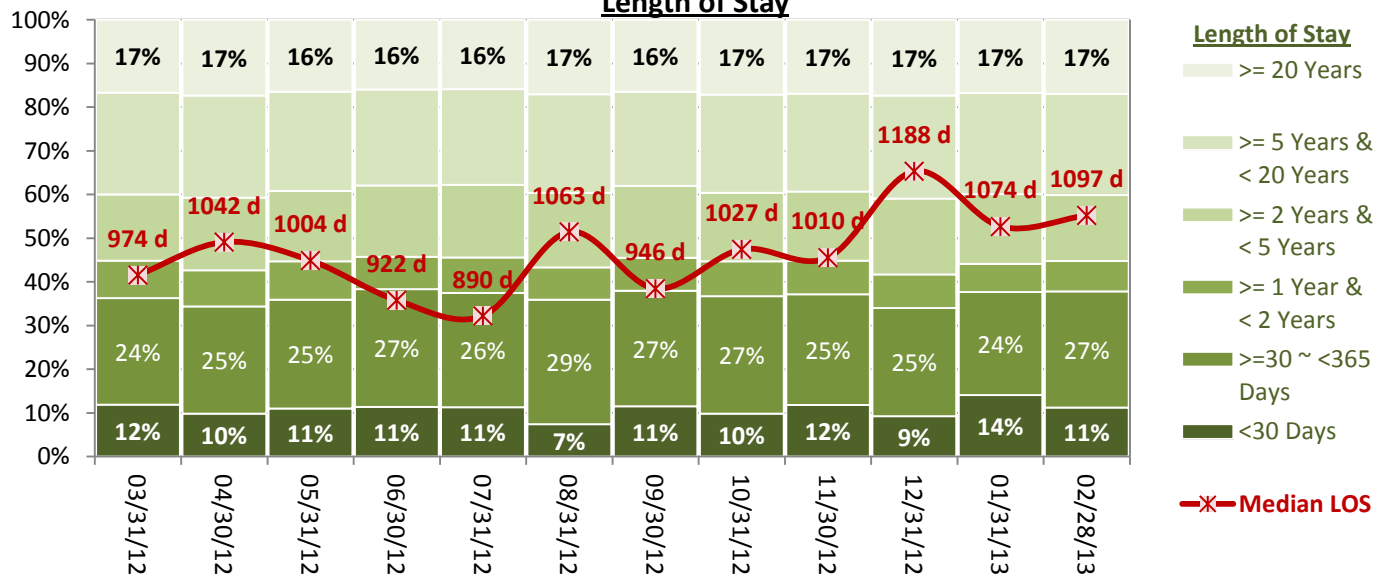
of Individuals by Legal Status (2/28/13)
