The District of Columbia Public Schools (DCPS) issued the subject Request for Proposal (RFP) GAGA-2016-R-0036A seeking competitive responses from Prospective Contractors. The RFP issued on December 17, 2015 stimulated several questions from interested Contractors which require amendments to the RFP. DCPS is issuing the following amendments to the RFP:

1. **Delete Section B.5.1 in its entirety.**

Insert: Section B.5.1: The quantities provided in the OFNS School Sites Profiles in accordance with Section C.4.9 are the projections based on 2015-16 year-to-date data. DCPS does not guarantee the actual quantities of meals nor establish norms for stable or normal operations.

2. **Delete Section C.1.3.3 in its entirety.**
3. **Delete Section C.1.4.1.1 in its entirety.**

Insert: Section C.1.4.1.1: The Contractor(s) shall measure satisfaction among DCPS students via surveys to be administered twice per year. These surveys shall be subject to approval by DCPS.

4. **Delete Section C.1.4.1.2 in its entirety.**

Insert: Section C.1.4.1.2: The Contractor(s) shall conduct waste studies administered twice per year to further determine consumption rates and relationships to satisfaction.

5. **Delete Section C.2.13 in its entirety.**

Insert Section C.2.13: A student whose meal service transaction was ignored because the prior student's transaction had not been completed.

6. Delete Section C.3.4.1 in its entirety.

Insert Section C.3.1.1: "Offer versus Served (OvS) will apply to all grades in section C.4 Item 17, USDA guidance Offer vs. Serve.

7. Delete Section C.3.10.1.1 in its entirety.

Insert Section C.3.10.1.1: Participation data for breakfast, lunch, and supper (monthly analyzed, week prior year, year to date (YTD) and last year to date (LYTD));

8. Delete Section C.3.13.7 in its entirety.

Insert Section C.3.13.7: The Contractor (s) shall clean the dining/cafeteria area, including tables and chairs after the meal service. With the exception of clearing immediate debris in compliance with DOH sanitation standards, DCPS shall be responsible for daily final cleaning of floor surfaces.

9. Delete Section C.3.22.6.1.1 in its entirety.

Insert Section C.3.22.6.1.1: The Contractor(s) shall create an afterschool supper menu that features a variety of menu items and includes all reimbursable meal components. Per C.3.22.6.1 meals served shall conform to the same meal pattern requirements as meals served under the CAFCP Program.

10. Delete Section C.3.26.6 in its entirety.

Insert Section C.3.26.6: The Contractor(s) shall maintain the same minimum level of employee positions, hours, wages, and benefits for the entire Contract Term, and each subsequent Contract Term, as applicable, unless a reduction in the required levels is authorized by DCPS. DCPS shall review and give consent to all management /supervisory staff hired during the term of the contract. Contractor(s) are not obligated to honor any existing collective bargaining agreements toward the fulfillment of the contract(s) resulting from this RFP.

11. Delete Section C.3.26.24.1 in its entirety.

Insert: Section C.3.26.24.1: Routine monitoring shall consist of a quality assurance Operations Site Review, as found in section C.4 Item 4.

12. Delete Section G.1.3 in its entirety.

Insert: Section G.1.3: The Contractor(s) shall submit its itemized invoice to the DCPS monthly, as specified. Each invoice shall give a detailed breakdown of the number of meals delivered at each school during the preceding month. Payment will be made at the unit price specified in the contract.

13. Section H.11.11 is only applicable if in accordance with H.11.3: The Contractor(s) shall also obtain traffic records to investigate persons applying for employment, as well as current employees and volunteers, when that person will be required to drive a motor vehicle to transport children in the course of performing his or her duties.
