## PUBLIC NOTICE (PUBLIC COMMENT PERIOD EXTENDED UNTIL MARCH 28, 2022)

## RM40-2022-01-E, SMALL GENERATOR INTERCONNECTION SYSTEM UPGRADES,

- 1. The Public Service Commission of the District of Columbia (Commission) informs interested persons of an extension of time to file comments in response to the January 28, 2022, Notice of Proposed Rulemaking (NOPR) published in the *D.C. Register*. This Notice supersedes the January 28, 2022, NOPR, and comments to the NOPR are now due by March 28, 2022.
- 2. The purpose of the published NOPR is to address electric distribution system upgrade costs related to the interconnection of customer-generators for the purposes of net energy metering. The NOPR proposes treating the customer-generator upgrade costs in a similar manner to that of Community Renewable Energy Facility (CREF) system upgrade costs. Additionally, the proposed Rule 4005.6(d) will establish reporting that will assist the Commission in further review of the overall costs and benefits associated with the electric distribution system upgrades. On February 22, 2022, a Motion for Enlargement of Time to file comments was filed.<sup>2</sup> Through this Public Notice, the Commission hereby extends the comment period from February 28, 2022, to March 28, 2022.
- 3. Any person interested in commenting on this proposed rulemaking action may submit written comments, not later than thirty (30) days after publication of this Notice in the *D.C. Register*.
