**PUBLIC NOTICE EXTENDING COMMENT PERIOD**

**November 27, 2019**

**FORMAL CASE NO. 1137, IN THE MATTER OF THE APPLICATION OF  
WASHINGTON GAS LIGHT COMPANY FOR AUTHORITY TO INCREASE  
EXISTING RATES AND CHARGES FOR GAS SERVICE,**

1. By this Public Notice, the Public Service Commission of the District of Columbia (“Commission”) extends the time to file comments and reply comments on Washington Gas Light Company’s (“WGL” or “Company”) 2019 Depreciation Study (“Depreciation Study”).<sup>1</sup> On October 29, 2019, the Commission invited interested parties to submit comments on the Depreciation Study within 30 days and reply comments 15 days thereafter.<sup>2</sup> Subsequently on November 21, 2019, the Office of the People’s Counsel for the District of Columbia (“OPC”) filed an unopposed Unanimous Motion for Enlargement of Time (“Motion”) to extend the comment period by 60 days to January 29, 2020, and reply comments by 30 days to February 28, 2020.<sup>3</sup> On November 27, 2019, the Commission by Order No. 20259 granted OPC’s Motion. The new deadline to file Comments on the Depreciation Study is January 29, 2020, and the deadline for replies is February 28, 2020.

2.
