

Dr. Bowman asked the family of former Chairman James A. Washington. Jr. (1961-1966) to stand and be recognized for their father's pioneering role in the hiring of minorities in the public utility industry in the District.



Dr. Bowman asked Mrs. Elsie Neely, widow of former Commissioner H. Mason Neely (1971-1977), to stand and be recognized. Absent was former Chairman George A. Avery who continued Chairman Washington's efforts. Dr. Bowman's husband, John H. Bowman, is applauding while seated.

JAMES A. WASHINGTON, JR.

TERM: OCTOBER 2, 1961 - OCTOBER 7, 1966



In 1961, James A. Washington, Jr. was appointed by President John F. Kennedy to be a Commissioner of the PUC and President Lyndon Johnson reappointed him to the PUC in 1964. He was immediately elected by his fellow Commissioners to be the Chairman, serving from October 22, 1961 until October 7, 1966. During his tenure, the name of the PUC changed to the Public Service Commission of the District of Columbia (PSC) after the agency was given additional authority to regulate the securities industry in the District.

A native of Asheville, NC, Chairman Washington moved to the District at the age of 7 and graduated from Dunbar High School, where he met his future wife. He graduated from Howard University in 1936 and earned a law degree there in 1939. He earned a Master's of Law from Harvard Law School in 1941 and joined the faculty of Howard University School of Law in 1946. While at Howard School of Law, he served on the legal team for the Bolling vs. Sharpe companion case to the Brown vs. Board of Education case that desegregated public schools.

Upon leaving the PSC, Chairman Washington continued his career as a legal scholar, teacher, and public servant. He became Dean of the Howard University Law School in 1969 after serving as the Langston Professor of Law there for 3 years. President Nixon appointed him to be General Counsel for the U.S. Department of Transportation, and he held that position from 1969 – 1971, when he became an Associate Judge for the District of Columbia Superior Court. Although he was partially paralyzed from a broken neck during a fall in 1976, after a year of physical therapy, he returned to work as a judge and he retired from the Court in 1984. Judge Washington passed away on August 29, 1998.
