Access to Care

- ★ Providing enrollees with access to care, tests, or treatments
- ★ Enrollees reporting they are able to get care they need, as quickly as they need it

Doctor's Communication and Service

- ★ Enrollees reporting satisfaction with how well their doctor explains things in a way that is easy to understand
- ★ Doctors listening carefully, showing respect, and spending enough time with enrollees

Performance Area Descriptions

Keeping Kids Healthy

★ Children receiving care needed to stay healthy and prevent illness, such as immunizations, well-child visits, and lead screening

Care for Kids with Chronic Illness

- ★ Children having access to medication and special medical equipment or devices
- ★ Enrollees reporting satisfaction with level of personal attention and how informed the doctor is about the child's needs

Care for Adults with Chronic Illness

★ Providing care and services to help people manage chronic illness, such as diabetes, asthma, and high blood pressure

Taking Care of Women

- ★ Care women receive before and after having a baby
- ★ Providing women with services that maintain good health, such as breast cancer, cervical, and chlamydia screenings
