Access to Care

- ★ Doctors answering questions and providing clear explanations

Keeping Kids Healthy

★ Children receiving care to stay healthy, such as regular doctor visits, immunizations, lead tests, and dental care

★ Children with chronic illness, such as asthma, receiving special care, information, equipment, and medicine

Care for Adults with Chronic Illness

★ Adults with chronic illness, such as diabetes, receiving special care, tests, and medicine

Taking Care of Women

- ★ Women receiving care before and after having a baby
- ★ Providing women with services that maintain good health, such as screenings for breast and other female cancers
