AGREED SETTLEMENT

In consideration of the above matter and as the full and final resolution of this matter, the undersigned parties do hereby consent and agree to the following:

1. The South Dakota Department of Labor and Regulation, Board of Technical Professions (Board) has jurisdiction over this matter pursuant to SDCL Chapter 36-18A.
2. ARSD Chapters 20:38:29 and 20:38:34 require that prospective licensees file an application with the Board.
3. Gary Maji (Applicant) applied for comity licensure as a professional engineer with the Board on October 18, 2021.
4. Applicant is not and has never been licensed as a professional engineer in South Dakota.
5. On May 25, 2022, Applicant's comity application for licensure was considered by the Board and the Board voted to deny the application.
6. On June 14, 2022, the Board office served notice of the denial upon Applicant by U.S. Mail. The Board's basis for its denial was the Board's finding, based on the available evidence, that Applicant had practiced or offered to practice engineering on an engineering project in South Dakota (Project) without being licensed in South Dakota.

7. On July 11, 2022, Applicant timely appealed the denial and requested a contested case hearing pursuant to SDCL Ch. 1-26.
8. On August 11, 2022, the Board office received correspondence from the client on the Project indicating that Applicant had not provided engineering services on the Project, and clarifying Applicant's role as Project Manager on the Project.
9. Pursuant to SDCL 1-26-20, Applicant agrees that this Agreed Settlement shall serve as the full and final resolution of his application, including his appeal.
10. Upon execution of this document, the Board agrees that its denial of Applicant's comity licensure application shall be immediately rescinded.
11. Similarly, upon execution of this document, Applicant agrees that his application for licensure shall be immediately withdrawn.
12. Applicant voluntarily agrees to refrain from submitting any application for licensure with the Board for at least 36 months from the date of execution of this document. If Applicant submits any application within 36 months following execution of this document, the Board may deny any such application based solely on this Agreed Settlement.
13. The parties agree that this Agreed Settlement makes no finding or determination of unprofessional conduct by Applicant and no discipline is imposed upon Applicant.
14. The parties agree that the disposition of the application shall be recorded as

“withdrawn”.

15. Applicant is aware that he may choose to be represented by legal counsel in this matter and is represented in this matter by Brian Zielinski of Ribstein & Hogan Law Firm.
16. Applicant is aware of and understands the nature of this matter and has been informed of his right to counsel, notice, hearing, and appeal, and that by agreeing to and signing this Consent Agreement, Applicant waives all procedures and proceedings before the Board to which he may be entitled under state or federal law.
17. Applicant understands that the terms of this Agreed Settlement will be public.
18. Applicant understands that this Agreed Settlement is a full and final resolution of only those facts related to this application for licensure and his work related to the Project at issue in this dispute, which served as the basis for the appeal. Nothing in this Agreed Settlement will be deemed to restrict the Board from considering any other historical facts or potential licensure issues, not involved in this matter, in any future application for licensure before the Board. The intent of this Agreement is to fully and finally resolve the Parties' dispute related to Applicant's work on the Project and his application for licensure insofar as it relates to the Project.
19. Applicant consents, agrees, and acknowledges that this Agreed Settlement must be submitted to the Board for acceptance or rejection. In the event the Board rejects the recommendations for resolution by Agreed Settlement, Applicant waives any right to claim prejudice or to request recusal of any board member by reason of any factual basis submitted to the Board in an effort to resolve this matter by Agreed Settlement rather than by formal proceeding.

20. Each party agrees to be responsible for their own attorneys' fees and costs in this matter.
21. Applicant has read, understands, and agrees to this Agreed Settlement and is freely and voluntarily signing it. This Agreed Settlement contains the entire agreement between the parties relating to the matters referenced in the Agreed Settlement. Applicant is not relying on any other representations of any kind, verbal or otherwise.
22. Applicant agrees to waive any rights and procedures afforded him under SDCL Chapters 1-26, 36-18A, 36-1C, and ARSD Article 20:38.
23. If this Agreed Settlement is approved by the Board, a copy of the executed Agreed Settlement will be served by first class mail on Applicant by mailing a copy to his attorney, Brian Zielinski, at Ribstein & Hogan Law Firm, 621 Sixth Street, Brookings SD 57006.


