

### Supply Chain Assistance Funding School Year 2022-2023

U.S. Dept of Agriculture (USDA) Food and Nutrition Service (FNS) allocated relief funding through the Commodity Credit Corporation to provide financial assistance to operators of the National School Lunch Program (NSLP) and School Breakfast Program (SBP), in an effort to assist with labor stress and disruptions due to supply chain demands.

Payments of round 1 SCA funding were made March 2022. Payments of round 2 and 3 SCA funding, including a small amount of round 1 reallocated SCA funds, were made in March 2023. The list below contains all School Food Authorities that accepted SCA funds and their final allocation amount.
