Ways to Pay Child Support Payment Options



Payment Method	Where to Make or Set Up Payments	Fees	Additional information
Income Withholding	Payment is withheld from your paycheck and submitted by your employer.	Your employer may charge up to \$3 per month. Note: Income withholding is available to non-enforced cases by completing an application with \$25 application fee.	This is the default method of payment used by DCS, as required by federal regulations. An income withholding order will automatically generate to a known employer unless Automatic Payment Withdrawal is in place.
Automatic Payment Withdrawal	Talk to your Child Support Specialist.	Fees may be charged by your financial institution.	This option allows the payer of support to have support payments withdrawn from a bank account in lieu of income withholding. To see if you qualify, contact your Child Support Specialist.

PayPal	ExpertPay.com	2.95% of the payment amount (up to \$60)	Please allow 3-5 business days for payments to appear on your case.
