PRIVATE MEMBERS' BUSINESS

(BILLS FOR CONSIDERATION AND PASSING)

1. **FURTHER DISCUSSION** on the motion moved by Dr. Sipra Mallick on 07.09.2012 that the Odia Biswabidyalaya Bill, 2011 be taken into consideration.
DR. SIPRA MALLICK to move that the Bill be passed.
2. **SHRI BISHNU CHARAN DAS** to move that the Odisha Prohibition of Obscene Songs Bill, 2012 be taken into consideration.
ALSO to move that the Bill be passed.
3. **SHRI PRASAD KUMAR HARICHANDAN** to move that the Orissa Repealing Bill, 2011 be taken into consideration.
ALSO to move that the Bill be passed.
4. **SHRI NABA KISHORE DAS** to move that the Odisha Reservation of Vacancies in Posts, Services and Grades in Private and Private-Public Participatory Mode Companies (For Scheduled Castes and Scheduled Tribes), Bill, 2012 be taken into consideration.

1. **FURTHER DISCUSSION** on the following Resolution moved by Shri Anup Kumar Sai on 19.08.2011:-
"That this House recommends to the Government to urge upon the Central Government to accord necessary clearance for establishment of a special bench of Hon'ble High Court in Western Orissa in greater interest of poor people of Western Orissa whose financial condition does not permit them to go to Hon'ble High Court at Cuttack to attend their cases".
2. **SHRI PRASAD KUMAR HARICHANDAN** to move the following Resolution, namely:-
"Whereas, the farmers of the State are distressed and unable to afford the electricity charges for irrigation and allied agricultural needs;

Therefore, the House recommends to Govt. that free power be supplied to the Agriculture Sector in the State."

3. **SHRI PRAFULLA SAMAL** to move the following Resolution, namely:-
"That this House recommends to the Government to take immediate steps to declare Bhadrak Autonomous College as an Unitary University".

4. **SHRI PRAVAT RANJAN BISWAL** to move the following Resolution, namely:-

6. **SHRI PRASAD KUMAR HARICHANDAN** to move the following Resolution, namely:-
"Whereas, to provide extensive representation to the people in the State Legislature and to establish healthy and strong democratic traditions, it is necessary to create Legislative Council in the State;
Therefore, in pursuance of clause (1) of Article 169 of the Constitution of India, this House resolves that a law may be passed by the Parliament to create Legislative Council in the State of Odisha".
