But the focus of every conference schedule is on education. Every conference covers both introductory and advanced material for students to learn about libertarianism at every level. SFL ran 51 conferences for more than 9,000 attendees in FY15.

(Revenue \$) Leadership Programs - SFL's emphasis on leadership development has been the key to the organization's success over the years. SFL teaches young people entrepreneurship, event-planning, volunteer management, effective writing, public speaking, and other skills that they can use throughout their lives, and gives them experience applying these skills in building the student movement for liberty. SFL trained 686 student leaders that engage with 1,773 student groups across the world.
