MONTHLY LIQUEFIED NATURAL GAS STORAGE REPORT FORM EIA-191L INSTRUCTIONS

PURPOSE

The U.S. Energy Information Administration (EIA) Form EIA-191L, *Monthly Liquefied Natural Gas Storage Report*, provides data on the operations of all active liquefied natural gas (LNG) peak-shaving, satellite, and marine terminal facilities. The data appear in the EIA publications *Monthly Energy Review*, *Natural Gas Annual*, and *Natural Gas Monthly*.

WHO MUST SUBMIT

Form EIA-191L is mandatory under 15 U.S.C. §772(b) and all companies that operate liquefied LNG peakshaving and satellite storage facilities in the United States must provide the information requested. Operators of underground storage facilities must complete Form EIA-191. Note that only operators of LNG peak-shaving and satellite facilities must complete Form EIA-191L. Operators of marine terminals or LNG vehicle fueling stations are not required to report.

WHEN TO SUBMIT

You must file within 20 days after the last day of the report month. You must file twelve reports per calendar year.

If additional facilities are acquired, or if storage activities begin in a new facility during the year, you must enter their field characteristics for the month when initial activity began.

HOW TO SUBMIT

Instructions on where to report via secure file transfer are below and printed on Part 2 of Form EIA-191 and Form EIA-191L.

Secure File Transfer: You can file through the Secure File Transfer System. The secure hypertext transfer protocol (HTTPS) is a secure, encrypted method to send information electronically. All information is protected by 128-bit encryption to maintain the privacy and confidentiality of transmitted data. Files must be saved to your personal computer. Data cannot be entered interactively on the website.

HOW TO COMPLETE THE SURVEY FORM

Report all volumes in thousand cubic feet (Mcf). Do not report any negative values on any part of the Form EIA-191L.

Provide data for all facilities your company operates. You may copy additional forms or download additional electronic files when submitting data for more than two facilities.

Reporting of preliminary or estimated data is allowable, if necessary, to meet the due date. You only have to file a revised report if actual or corrected data vary more than plus or minus 4% from the data previously reported.

SPECIFIC INSTRUCTIONS

PART 1: RESPONDENT IDENTIFICATION DATA

Provide up-to-date company information.

EIA ID number: Enter the 10-digit EIA ID number. Companies operating in more than one State should note that a unique number has been assigned for operations in each state. If we haven't assigned an ID number to you, leave the space blank and contact us at (877) 800-5261.

Resubmission: Check the box if the report is a revised report. If the report is an original, leave this space blank.

Company name: Enter the company name.

Contact information: Enter the current contact information.

PART 2: SUBMISSION INFORMATION

You can submit your completed Form EIA-191L via Secure File Transfer.

PART 3: FACILITY CHARACTERISTICS

Report all volumes in thousand cubic feet (Mcf), 14.73 psia-60° F, as of 9:00 a.m., Central Standard Time (CST) on the last day of the report month. Do not complete data items that are grayed out.

For Facility status, check the appropriate box for either active or inactive. A facility is "inactive" if it has not had any injections for at least the twelve months prior to this report month, or is in the process of abandonment. If "inactive," provide additional information in the comments section about the circumstances.

PART 4: MONTHLY GAS STORAGE

You must provide information for your facilities as defined below in the Definitions. Report all volumes in thousand cubic feet (Mcf), 14.73 psia-60o F, as of 9:00 a.m. CST on the last day of the report month. In most cases, net injections or withdrawals should correspond to the difference between total gas volume for the current and prior report period. Include storage compressor use volumes with the injections and withdrawals totals.

Comments: Use the comment space to describe any unusual or substantially different aspects of your monthly operations that affect the data you reported.

DEFINITIONS

Injections: The volume of gas injected into storage facility or reservoir during the report month.

Maximum Deliverability: The maximum rate (Mcf/day) natural gas can be withdrawn (or delivered) from a storage facility when filled to maximum capacity.

Total Gas in Storage: The total volume of natural gas held in aboveground storage tanks.

Total Storage Capacity: The maximum volume of natural gas that you can store in a facility based on its design specifications, installed compression equipment, and operating procedures particular to the site.

Withdrawals: The volume of gas withdrawn from storage facilities during the report month.

Peakshaving Facility: An LNG storage facility which regasifies natural gas during periods of peak demand, such as during the wintertime.

Satellite LNG Facility: An LNG storage facility which allows natural gas utilities that are not connected to the pipeline grid to supply natural gas to customers. LNG is typically delivered by truck or train.

SANCTIONS

Form EIA-191L is mandatory under 15 U.S.C. §772(b). Failure to respond may result in a civil penalty of not more than \$10,821 each day for each violation. The government may bring a civil action to prohibit reporting violations which may result in a temporary restraining order or a preliminary or permanent injunction without bond. In such civil action, the court may also issue mandatory injunctions commanding any person to comply with these reporting requirements.

DISCLOSURE OF INFORMATION

Information collected in Parts 1, 2, and 3 on Form EIA-191L is considered public information, and may be publicly released in company or individually identifiable form. Information collected in Part 4 however, will be protected and will not be disclosed to the public to the extent that it satisfies the criteria for exemption under the Freedom of Information Act (FOIA), 5 U.S.C. §552, the DOE regulations, 10 C.F.R. §1004.11, implementing the FOIA, and the Trade Secrets Act, 18 U.S.C. §1905.

The Federal Energy Administration Act requires EIA to provide company-specific data to other federal agencies when requested for official use. The information you reported on this form may also be made available, upon request, to another component of the Department of Energy (DOE); to any Committee of Congress, the Government Accountability Office, or other federal agencies authorized by law to receive such information. A court of competent jurisdiction may obtain this information in response to an order. The information may be used for any nonstatistical purposes such as administrative, regulatory, law enforcement, or adjudicatory purposes.

Disclosure limitation procedures do not apply to the statistical data published from EIA-191L survey information. Some statistics may be based on data from fewer than three respondents, or may be dominated by data from one or two large respondents. In these cases, a knowledgeable person may be able to closely estimate the information a specific respondent reported.

FILING FORMS WITH FEDERAL GOVERNMENT AND ESTIMATED REPORTING BURDEN

Public reporting burden for this collection of information is estimated to average 2.6 hours per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information.
