MONTHLY LIQUEFIED NATURAL GAS STORAGE REPORT

YOUR RESPONSE IS REQUIRED BY LAW

This report is mandatory under Title 15 U.S.C. §772(b). Failure to comply may result in criminal fines, civil penalties and other sanctions as provided by Title 15 U.S.C. §797. Title 18 U.S.C. §1001 makes it a criminal offense for any person knowingly and willingly to make to any Agency or Department of the United States any false, fictitious, or fraudulent statements as to any matter within its jurisdiction.

The Form EIA-191L must be completed by all companies that operate liquefied natural gas (LNG) peak-shaving and satellite storage facilities in the United States. Operators of underground storage facilities must complete Form EIA-191 *Monthly Underground Natural Gas Storage Report*. Note that only operators of LNG peak-shaving and satellite facilities must complete Form EIA-191L. Operators of marine terminals or LNG vehicle fueling stations are not required to report.

PURPOSE

The U.S. Energy Information Administration (EIA) Form EIA-191L, *Monthly Liquefied Natural Gas Storage Report*, provides data on the operations of all active liquefied natural gas (LNG) peak-shaving and satellite facilities, but excludes marine terminal facilities. The data appear in the EIA publications *Monthly Energy Review*, *Natural Gas Annual*, and *Natural Gas Monthly*.

RESPONSE DUE DATE

Respondents must file within 20 days after the last day of the report month. You must file twelve reports per calendar year.

If additional facilities are acquired, or if storage activities begin in a new facility during the year, you must enter their field characteristics for the month when initial activity began.

HOW TO FILE A RESPONSE

To facilitate the processing of data, the use of EIA forms is required. The form can be downloaded in XLS format on the EIA website, which can be accessed from http://www.eia.gov/survey/#eia-191L.

Respondents must use the EIA's Secure File Transfer system to submit their data. With this Internet-based option, EIA uses security protocols to protect the information against unauthorized access during transmission. EIA does not accept email, fax, or paper forms.

HOW TO USE EIA'S SECURE FILE TRANSFER

EIA is ensuring the security of your transactions by using the latest Internet security technology. The technology being used to protect your data is encryption which is the scrambling of data into a code that is unreadable to anyone who does not have the key that deciphers it. The secure hypertext transfer protocol (HTTPS) is a communications protocol designed to transfer this encrypted information between computers over the internet. All information is protected by 128-bit encryption to maintain the privacy and confidentiality of your data. The only thing you need to take advantage of strong encryption technology is a secure browser, one that supports 128-bit encryption.

- 1. Go to the EIA Secure File Transfer system located at <u>https://signon.eia.doe.gov/upload/noticeoog.jsp</u>
- 2. Read the Agreement and then click the **Accept** button.
- 3. Enter your name, company name, phone number and email address into the boxes provided. Note that the email address is required so that we can send you a confirmation of the receipt of your data.
- 4. Click on the **Choose Files** button to navigate to your saved Excel file submission. Select the file to upload and click on the **Open** button.
- 5. If you are ready to submit your file, click on the green **Submit File(s)** button. Please be patient, it may take a few minutes to upload your file. Do not close your browser during this upload. A confirmation page will be displayed with a Submission Successful banner and indicate the names of the files you have transferred, a confirmation number and the date and time of the transfer.

SANCTIONS

The timely submission of Form EIA-191L by those required to report is mandatory under 15 USC 772(b), as amended. Failure to respond may result in a civil penalty of not more than \$12,937 each day for each violation. The government may bring a civil action to prohibit reporting violations which may result in a temporary restraining order or a preliminary or permanent injunction without bond. In such civil action, the court may also issue mandatory injunctions commanding any person to comply with these reporting requirements.

REPORTING BURDEN

Public reporting burden for this collection of information is estimated to average 2.6 hours per response, including time for reviewing instructions, searching existing data sources, gathering and maintaining data needed, and completing and reviewing the collection of information. DISCLOSURE OF INFORMATION

Information collected in Part 3 of Form EIA-191L is considered public information and may be publicly released in company or individually identifiable form. Information collected in Parts 1 and 4 however, will be protected and will not be disclosed to the public to the extent that it satisfies the criteria for exemption under the Freedom of Information Act (FOIA), 5 U.S.C. §552, the DOE regulations, 10 C.F.R. §1004.11, implementing the FOIA, and the Trade Secrets Act, 18 U.S.C. §1905.

The Federal Energy Administration Act requires EIA to provide company-specific data to other federal agencies when requested for official use. The information you reported on this form may also be made available, upon request, to another component of the Department of Energy (DOE); to any Committee of Congress, the Government Accountability Office, or other federal agencies authorized by law to receive such information. A court of competent jurisdiction may obtain this information in

response to an order. The information may be used for any nonstatistical purposes such as administrative, regulatory, law enforcement, or adjudicatory purposes.

Disclosure limitation procedures do not apply to the statistical data published from EIA-191L survey information. Some statistics may be based on data from fewer than three respondents or may be dominated by data from one or two large respondents. In these cases, a knowledgeable person may be able to closely estimate the information a specific respondent reported.

SPECIFIC INSTRUCTIONS

PART 1: RESPONDENT IDENTIFICATION DATA

Provide up-to-date company information.

EIA ID number: Enter the 10-digit EIA ID number. Companies operating in more than one State should note that a unique number has been assigned for operations in each state. If we haven't assigned an ID number to you, leave the space blank and contact us at 1-855-EIA-4USA (1-855-342-4872).

Resubmission: Check the box if the report is a revised report. If the report is an original, leave this space blank.

Company name: Enter the company name.

Contact information: Enter the current contact information.

PART 2: SUBMISSION INFORMATION

Submission - Refer to the "How to File a Response" section for more details or method for submitting data.

PART 3: FACILITY CHARACTERISTICS

Report all volumes in thousand cubic feet (Mcf), 14.73 psia-600 F, as of 9:00 a.m., Central Standard Time (CST) on the last day of the report month. Do not complete data items that are grayed out.

For Facility status, check the appropriate box for either active or inactive. A facility is "inactive" if it has not had any injections for at least the twelve months prior to this report month or is in the process of abandonment. If "inactive," provide additional information in the comments section about the circumstances.

PART 4: MONTHLY GAS STORAGE

You must provide information for your facilities as defined below in the Definitions. Report all volumes in thousand cubic feet (Mcf), 14.73 psia-600 F, as of 9:00 a.m. CST on the 1ast day of the report month. In most cases, net injections or withdrawals should correspond to the difference between total gas volume for the current and prior report period. Include storage compressor use volumes with the injections and withdrawals totals.

Comments: Use the comment space to describe any unusual or substantially different aspects of your monthly operations that affect the data you reported.

DEFINITIONS

Injections: The volume of gas injected into storage facility or reservoir during the report month.

Maximum Deliverability: The maximum rate (Mcf/day) natural gas can be withdrawn (or delivered) from a storage facility when filled to maximum capacity.

Total Gas in Storage: The total volume of natural gas held in aboveground storage tanks.

Total Storage Capacity: The maximum volume of natural gas that you can store in a facility based on its design specifications, installed compression equipment, and operating procedures particular to the site.

Withdrawals: The volume of gas withdrawn from storage facilities during the report month.

Peak-shaving Facility: An LNG storage facility which regasifies natural gas during periods of peak demand, such as during the wintertime.

Satellite LNG Facility: An LNG storage facility which allows natural gas utilities that are not connected to the pipeline grid to supply natural gas to customers. LNG is typically delivered by truck or train.
