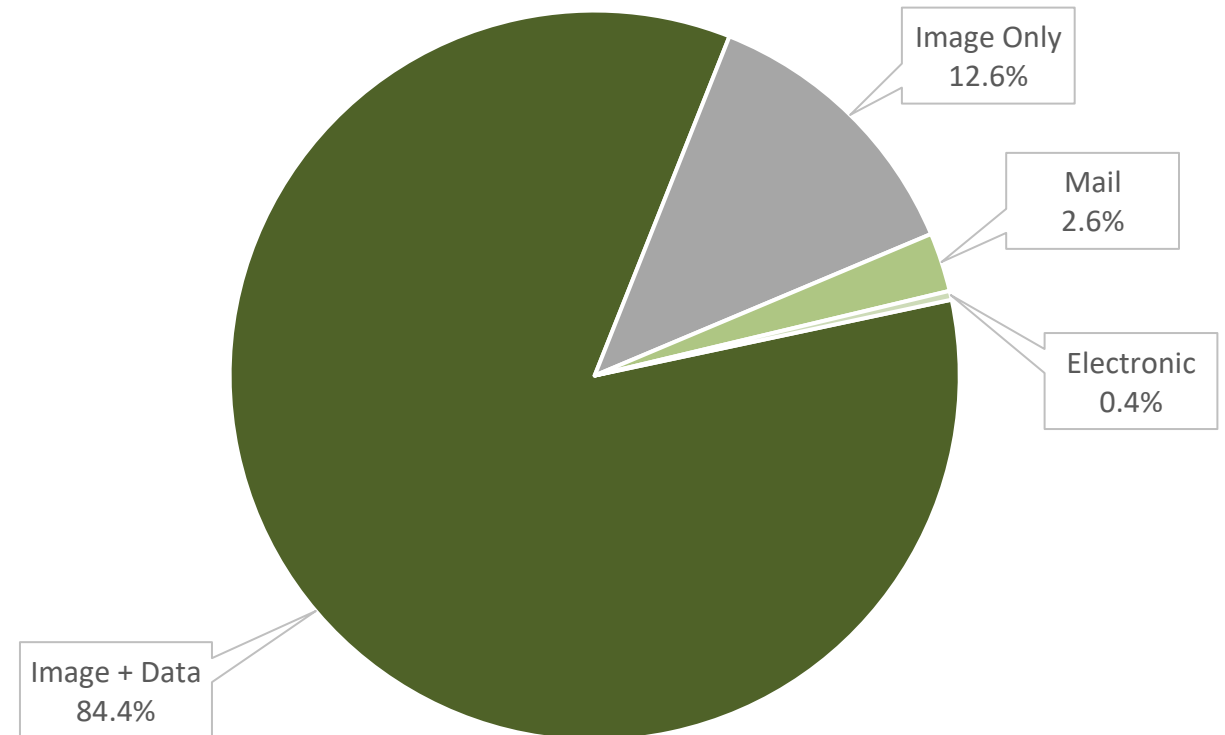

- The state wastes require a manifest under state law because:
 - The wastes are not federal hazardous wastes, but a state regulates them more broadly; and/or
 - A state has not adopted the federal manifest exemption or a conditional exclusion from the RCRA manifest requirements
- User Fees for FY2022/2023 – by July 1
- Planning for upcoming public meetings on increasing adoption of electronic manifests

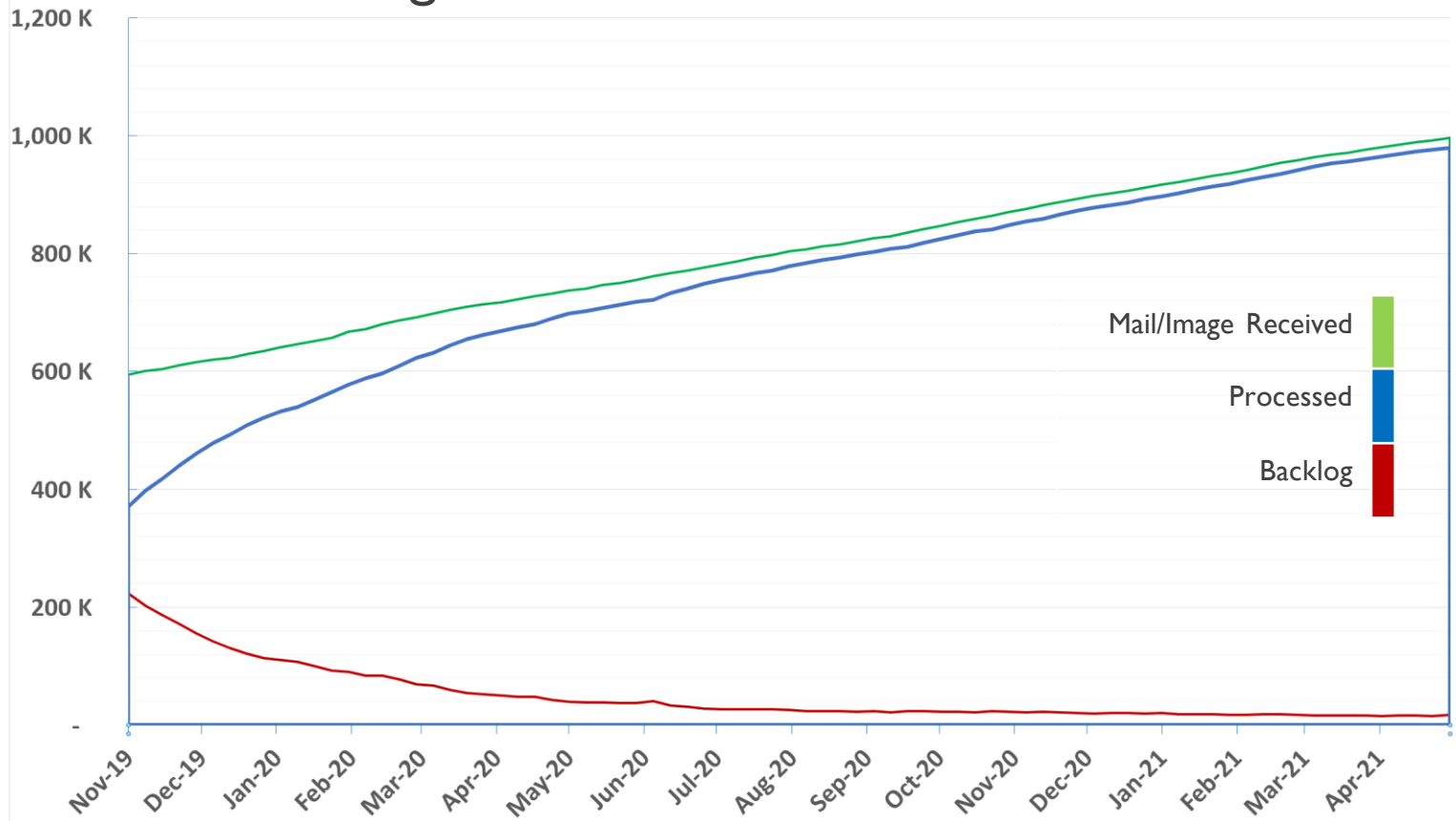

GENERATOR REGISTRATION

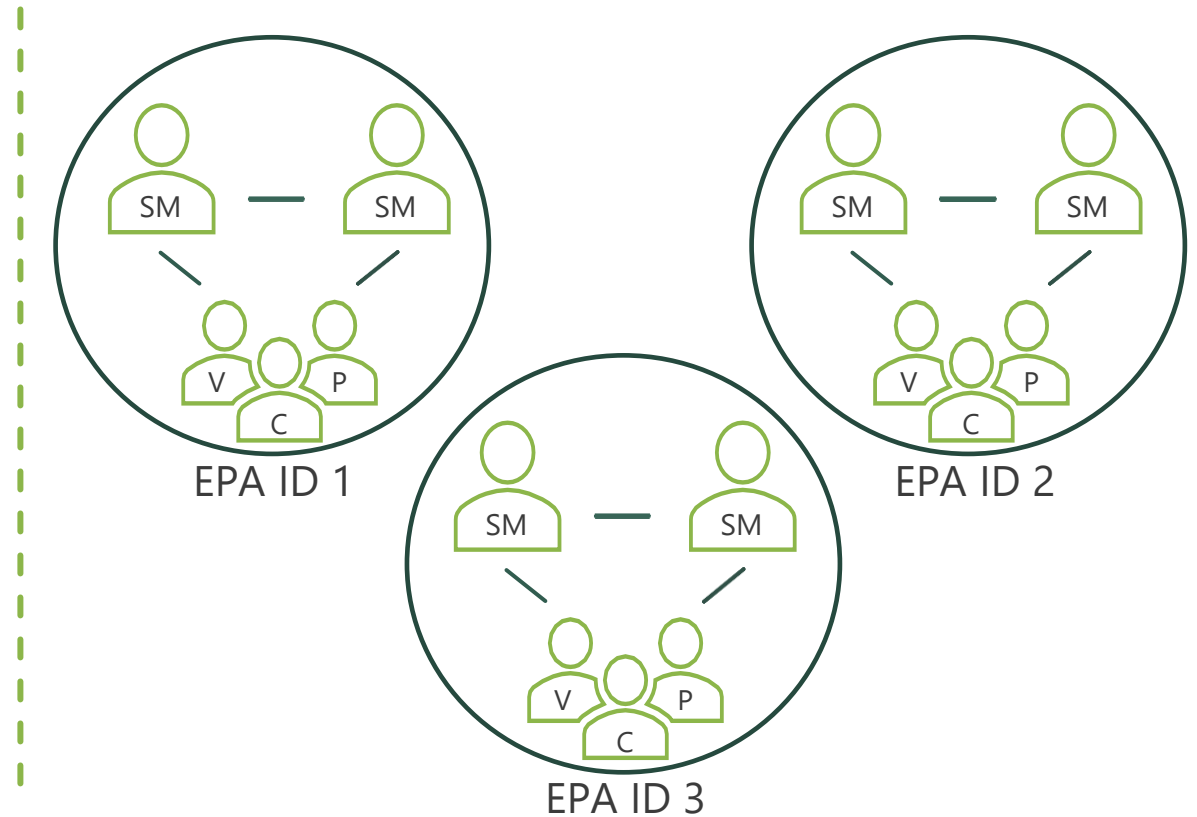
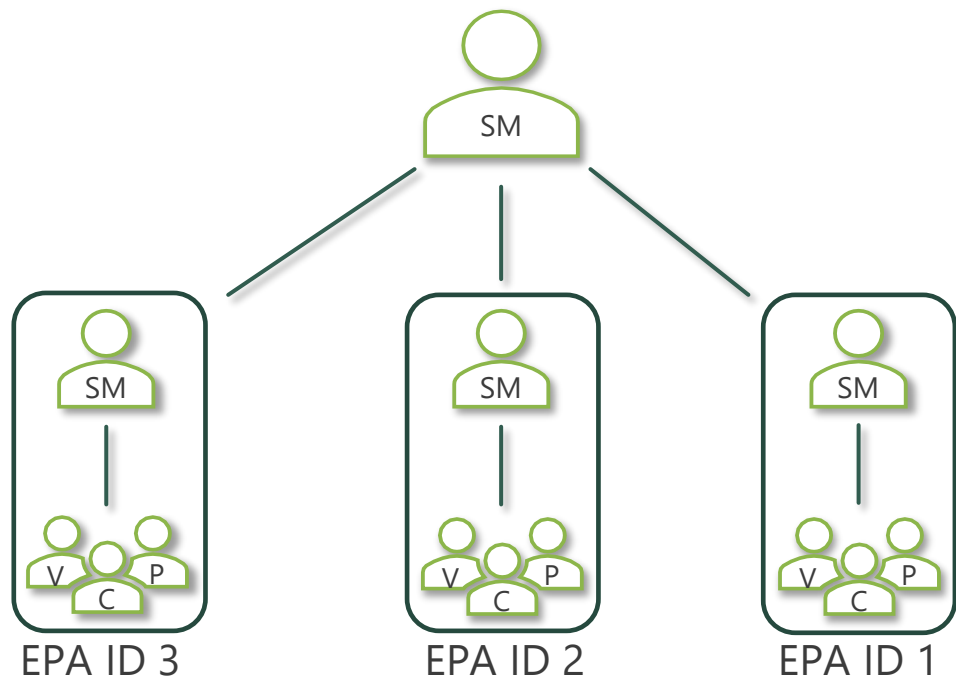
e-Manifest

- EPA is currently contacting generators and encouraging them to:
 1. Register in RCRAInfo
 2. Request site access
 3. View the data associated with their site ID and make any necessary corrections
- The focus is currently on large companies with multiple sites

GENERATOR REGISTRATION

e-Manifest

- There are multiple ways to organize site access permissions for generators that have multiple sites

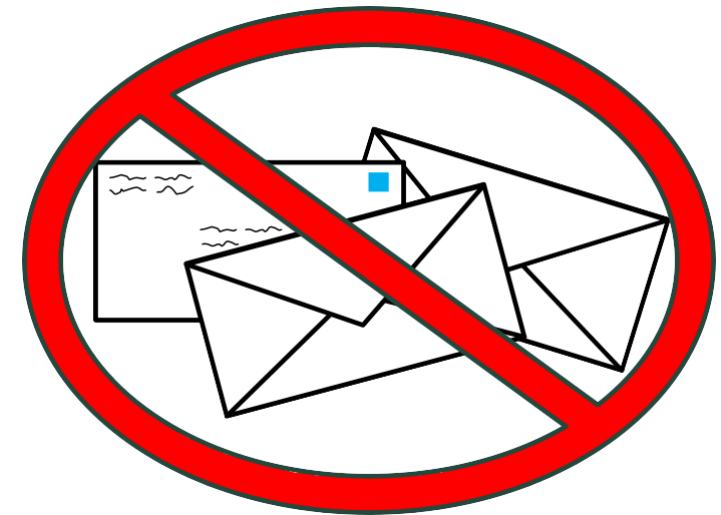


MAILED MANIFEST PHASEOUT

JUNE 30, 2021

e-Manifest

- Beginning June 30, 2021, EPA will no longer accept mailed paper manifests from facilities for processing in e-Manifest
- At that time, manifest and continuation sheet submissions will only be accepted in electronic, hybrid, data plus image, and image format
- After June 30, EPA will return to the sender any manifests and continuation sheets that are mailed to the e-Manifest PPC



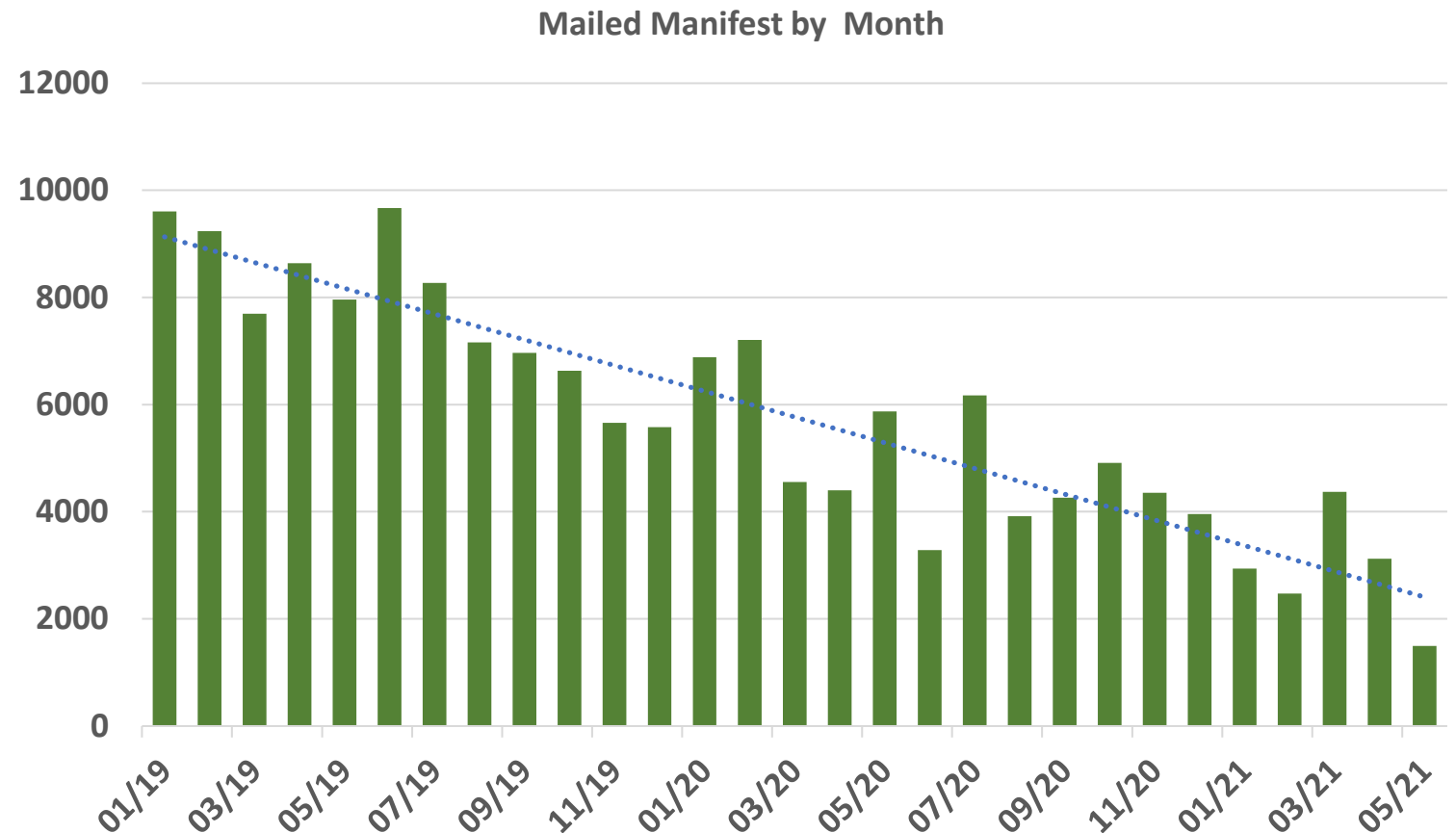

MAILED MANIFEST SUBMISSIONS PER MONTH

e-Manifest

- The number of mailed manifests has been decreasing
 - Currently only a few facilities continue to mail, and we are working with them to transition



- Copy manifest
- Site Search API (Coming May 28th)
 - API to Search for Sites based on address information to help sites ensure they are using the correct handler ID
