# Modern Slavery and Human Trafficking Statement

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 (the "Act") and sets out the steps that FTI Consulting LLP ("FTI Consulting") has taken during the financial year ending 31 December 2023 to ensure that slavery and human trafficking are not taking place in any part of FTI Consulting's supply chain or business.

#### **Policies**

The Act defines modern slavery as "slavery, servitude and forced or compulsory labour" as well as human trafficking. FTI Consulting uses the same definition of "modern slavery" in this statement.

As part of its commitment to the global community, FTI Consulting upholds individual human rights in all its operations.

This means, in part, that FTI Consulting provides reasonable working hours and fair wages for those who work on its behalf. FTI

Consulting opposes the use of modern slavery in all forms and has a zero-tolerance policy for the use of child or forced labour, or human trafficking practices, whether within its business or its supply chains. Further, FTI Consulting will not knowingly do business with sub-contractors, business partners or suppliers who violate these practices.

FTI Consulting adopts and adheres to the principles of the United Nations Global Compact ("UNGC"). Principle one is "the protection of internationally proclaimed human rights", principle four is "the elimination of all forms of forced and compulsory labour" and principle five is "the effective abolition of child labour".

The principles of the UNGC are enshrined in FTI Consulting's Code of Ethics and Business Conduct (the "Code of Conduct"), which also includes its policies on, among other things, equality and diversity, anti-corruption and whistleblowing. This Code of Conduct provides other information about how FTI Consulting conducts its day-to-day activities. New FTI Consulting staff are provided training on the Code of Conduct as part of their induction upon joining the firm. There is also regular refresher training for all staff to remind them of their obligations and FTI Consulting's expectations with regards to their conduct. The standards set out in the Code of Conduct are reflected in the firm's other policies and procedures and FTI Consulting aims to enshrine them in whatever it and its employees do. The Code of Conduct has previously been amended to make specific reference to modern slavery.

FTI Consulting also has a standalone

whistleblowing policy which encourages employees and third parties, including suppliers, to raise concerns of any improper conduct or violation of applicable laws or internal policies and procedures (including the Code of Conduct). FTI's employment and labour practices reinforce its approach to combatting modern slavery. FTI Consulting has created a safe, healthy and inclusive workplace with a strong culture of collaboration and respect for others. This is underpinned by a number of policies relating to diversity, dignity and inclusiveness which reflect a business environment in which the firm's ethical values are promoted.

#### **Supply Chain**

FTI Consulting's supply chain is extensive and includes a large number of suppliers providing a broad range of goods and services. In 2023, the top 10 suppliers accounted for 21% of its total annual supplier spend (and with the top 20 suppliers accounting for approximately 30% of total annual supplier spend). The majority of these suppliers are based in the UK. As in previous reporting periods, these key suppliers are the businesses which help the firm to run its office premises (e.g. catering, utilities) or who supply the firm with the technology, infrastructure and other support needed to run its business and serve its clients (e.g. IT, telecoms, recruitment, stationery, supplies and professional services). A number of these first-tier suppliers have been working with the firm for a number of years.

FTI Consulting has one preferred supplier which provides all of its catering, hospitality, switchboard and reception services and

another preferred supplier which provides all of its mail, print, courier and associated document management services as well as on site cleaning services and specialist advice and guidance on security issues.

Each of these suppliers has a current UK Modern Slavery Act Statement for the most recent reporting period, which sets out the steps they have taken to ensure that slavery and human trafficking are not taking place in any part of their business or supply chain.

## Risk assessment and due diligence

FTI Consulting's suppliers vary both in the nature of the services they provide as well as in the frequency with which FTI Consulting works with them - some are one-off or infrequent; others represent a substantial proportion of our annual supplier spend and/or are day-to-day suppliers.

As a professional services firm, FTI Consulting continues to consider that the risk of modern slavery existing within its business is low, when compared to other industries. FTI Consulting is of the view that there is a risk of modern slavery within its supply chain (including suppliers of personnel, goods and services), although considers the risk overall as low, given the nature of our business and the nature and types of goods and services provided by our suppliers. FTI Consulting is committed to continue improving its practices and sets out below steps FTI Consulting has taken and proposes to take to investigate and ensure that modern slavery does not take place in any part of its business or supply chain:

- FTI Consulting updated the Code of Conduct (as well as the associated training on that code) and will continue to review the Code of Conduct annually to ensure it reflects modern slavery risk;
- FTI will continue to assess and analyse its supplier related processes to ensure it maintains high standards;
- FTI Consulting published and will continue to publish this statement internally to raise awareness within its workforce; and
- FTI Consulting has taken steps to further develop, on an ongoing basis, additional steps it can take in respect of our existing supply chain to ensure that our suppliers (particularly first-tier suppliers and those suppliers who, by the nature of the goods and services they provide and/or the geographic location from which such goods and services are provided, are at a higher risk of modern slavery) adhere to the highest moral and ethical standards in their business activities and dealings. In 2023, FTI Consulting ensured that employees of suppliers working at FTI Consulting premises obtained salary reviews and appropriate increases.

If FTI Consulting becomes aware of an incident of modern slavery within its supply chain, FTI Consulting will work with the relevant supplier to implement swift remedial action (which may include termination of the underlying contract).

In determining the appropriate remedial action, consideration will naturally be given to the action(s) which will deliver the safest and best outcome for the potential victims of modern slavery. FTI Consulting expects its

suppliers to engage with FTI Consulting constructively and responsibly and to show their determination and willingness to rectify issues promptly and effectively.

### Effectiveness and Performance Review

Any instance of modern slavery would constitute non- compliance with, and a breach of, applicable employment laws, policies and practices, contracts and/or the Code of Conduct. FTI Consulting meets at least annually with a number of its key / first- tier suppliers (for example, catering, cleaning, mail/print room service providers) to discuss performance issues.

FTI Consulting also continues to risk assess our existing supply chain in order to be vigilant to new or evolving areas of risk. FTI Consulting will continue to investigate whether there are any other steps we should be putting into place to reduce the risk of modern slavery in our supply chain or ways in which we can increase awareness among our staff.

#### Training and awareness

Upon joining FTI Consulting and annually thereafter, all staff are given training on the Code of Conduct, which makes clear the firm's zero- tolerance policy for the use of modern slavery in FTI Consulting's business and supply chain. As mentioned above, FTI Consulting publishes this statement internally in order to raise awareness. This statement is made pursuant to section 54(1) of the Act and constitutes FTI Consulting LLP's slavery and human trafficking statement for the financial year ended 31 December 2023.
