

# 令和6年能登半島地震に伴う 雇用保険の基本手当の特例措置について

## 1 ハローワークに来所できない場合は、「失業の認定日の変更」ができます。

本地震の影響により、指定された失業の認定日にやむを得ず、ハローワークに来所できなかったときは、来所可能な日に失業の認定日を変更することができます。（事前の申し出ややむを得ない理由を証明する書類は不要）

失業の認定日に来所できなかった方は、来所日の前日までの失業認定を一括で行います。

※ やむを得ない場合は、応募等の求職活動実績がなくても支給されます。

## 2 他のハローワークでも失業認定の手続きができます。

本地震による交通の途絶や遠隔地への避難などにより、居住地を管轄するハローワークに来所できないときは、その他のハローワークで基本手当の受給手続きを行うことができます。

※ 受給手続きに必要な確認書類がない場合でも手続きを行うことができます。

## 3 「災害時における雇用保険の特例措置」があります。

本地震発生の時点で被災地域内の事業で勤務していた方について、

○災害により休業した場合

○災害により一時離職した場合

に雇用保険の基本手当を受給できる特例措置があります。

※制度利用に当たっての留意事項

本特例措置を利用して、基本手当の支給を受けた方については、休業又は一時離職後に、元の事業所に復帰して雇用保険被保険者資格を取得しても、当該休業又は一時離職前の雇用保険の被保険者であった期間は通算されません。

## Special Measures for the Basic Allowance of the Unemployment Benefits in Response to the 2024 Noto Peninsula Earthquake

### 1. You can change the date of the unemployment verification day if you are unable to visit Hello Work

If you are unable to come to Hello Work on the designated verification day due to the effects of the earthquake, you can change the verification day to another available date. (You are not required to inform us in advance nor bring documents proving your inevitable reasons)

For those who were unable to visit the office on the verification day, we will verify your unemployment for all days leading up to the day prior to your visit to our office.

※ The allowance would be paid even if you did not have job-seeking activities, such as applying to job postings, if there was an inevitable reason.

### 2. You can process the unemployment verification procedures at Hello Work offices outside your jurisdiction.

If you cannot visit the Hello Work office that has jurisdiction over your area due to transportation disruptions or evacuation to a distant location due to the earthquake, you can complete the procedures for receiving the basic allowance at another Hello Work office.

※ You can complete the procedure even without the necessary confirmation documents for the benefit reception with you.

### 3. There are “Special Measures for Unemployment Benefits in the Event of a Disaster”.

For everyone working at companies in the areas affected by the earthquake and are either:

- On leave from the workplace due to the disaster or
- Have become temporarily unemployed due to the disaster

We have a special measure in place through which you may receive the basic allowance of unemployment benefits.

#### ※Important notice for utilizing this measure

If you receive the basic allowance of unemployment benefits under this special measure, then the period during which you were insured under the employment insurance prior to the leave from work or the temporary unemployment, will not be carried over after you return to your employer, even if you become eligible for unemployment insurance.
