Product Description:

Safe Exam Browser SEB is a web browser environment to carry out e-assessments safely. The software turns any computer temporarily into a secure workstation. It controls access to resources like system functions, other websites and applications and prevents unauthorized resources being used during an exam.

Notes:

This VPAT does not make any statements about possible content. Content, in most cases electronic exams and tests in HTML from LMS, is entirely the responsibility of the users / examiners. Success criteria that refer to elements and functions that do not exist in Safe Exam Browser but could exist are reported as "Supports".

Known Issues:

- **No New Desktop Kiosk Mode**
 - **No "Create new desktop" Kiosk Mode:** The "Create new desktop" mode (SEB Configuration Tool > Security > Kiosk mode) does not work with tested screen readers (NVDA & JAWS).
 - **Use Disable Explorer Shell Kiosk Mode instead:** Alternatively, SEB can be run in Disable Explorer Shell Kiosk Mode.
- **Actions Center: [Win] + [A]:**
 - The Action Center can be displayed from the left edge of the screen using the keyboard short key **[Win] + [A]**.
 - The Action Center is not conveniently accessible in the current release (3.5.0). Especially for screen reader users. However, all relevant functions in the Action Center are accessible via the taskbar.
- **Keyboard shortcuts:**

Safe Exam Browser ensures that most relevant Windows operating system keyboard shortcuts also work within the SEB. Mentioned are

 - Dock: **[Win] + [D]** as well as **[Win] + [T]**; Navigate with **[Tab]** within taskbar.
 - Task view: **[Alt]+[Tab]**
 - Browser address bar: **[Ctrl]+[L]**
 - Action Center: **[Win] + [A]**

Note: We found that currently there is no way closing the "Application Protocol / log window" window using keyboard only. Will be fixed asap. Issue is considered not critical since function is used for debugging only.

Evaluation Methods Used:

Visual inspection, keyboard operation, screen reader tests with JAWS
