Product Description:

Safe Exam Browser is a web browser environment to carry out e-assessments safely. The software turns any computer temporarily into a secure workstation. It controls access to resources like system functions, other websites and applications and prevents unauthorized resources being used during an exam.

Success criteria that refer to elements and functions that do not exist in SEB but could exist are documented as “Supports”.

- Activate the «Use keyboard navigation to move focus between controls» checkbox (System Preferences > Keyboard > Shortcuts) to enable keyboard operability.
- Access menu bar and status bar using **VO + M** shortcut when using Voice Over and **^F2/F8** (control + F2) when navigating keyboard only. Note that, with our current setting (German keyboard), some keyboard shortcuts do not work. Neither in SEB nor anywhere else on the OS. E.g. **^F3** to go to the dock. This is general VO – keyboard layout compatibility issue.
- This VPAT is by now exclusive of the SEB configuration tool (> SafeExamBrowser > Settings), which is not activated in exam mode

Evaluation Methods Used:

Visual inspection, screen reader tests with Voice Over, keyboard operability (make sure > System Preferences > Keyboard > Shortcuts > «Use keyboard navigation to move focus between controls» checkbox)
