1. Member States

Permanent missions of Member States of the United Nations¹ will each receive one meeting-specific ticket to attend the 2024 SDG Moment taking place at the ECOSOC Chamber, on 24th September, from 1:30 to 3:15PM, from Protocol Office. **Please DO NOT contact or follow up with the Protocol Office for additional tickets.**

Missions who would like to obtain one or more passes to attend the event may do so by expressing interest to decadeofaction@un.org by Thursday 19 September, 4:00PM. The additional tickets will then be allocated, should there be enough tickets remaining, ahead of the event, to the respective missions, on a first come first served basis.

Those who have received confirmation by email can collect their additional tickets in person at the UN Secretariat Lobby, Café area (closer to the 42nd St), on Friday 20 September, 3:00 to 4:00 PM. Please come with your ID and confirmation emails.

2. Intergovernmental Organizations accredited by the UN General Assembly, and specialized agencies

3. Entities within the UN system²

One meeting-specific ticket to attend the 2024 SDG Moment will be reserved for UN agencies. UN agencies may collect their reserved meeting-specific ticket to the 2024 SDG Moment in person, at the UN Secretariat Lobby, Café area, on Friday 20 September, 3:00 to 4:00 PM. Please come with your ID. **Please DO NOT contact the Protocol Office for tickets.**

The UN agencies which would like to receive additional tickets will need to submit their request via email to decadeofaction@un.org by Thursday 19 September, 4:00PM. The additional tickets will then be allocated, should there be enough tickets remaining, ahead of the event, to the respective agencies, on a first come first served basis.

Those who have received confirmation by email can collect their additional tickets in person at the UN Secretariat Lobby, Café area (closer to the 42nd St), on Friday 20 September, 3:00 to 4:00 PM. Please come with your ID and confirmation emails. **Please DO NOT contact the Protocol Office for additional tickets.**

4. Civil society and other representatives

The ticket will then be allocated, should there be enough tickets remaining, ahead of the event, on a first come first served basis.

Those who have received confirmation by email can collect their ticket in **person at the UN Visitor's Services, next to the Tourist Meeting Point**, inside the UN Secretariat building, after passing security entrance to the UN building, at 47th street and 1st Avenue, on **Friday 20 September, 4:15 to 5:00 PM**. Please come with your ID and confirmation emails. Please DO NOT contact or follow up with the Protocol Office for additional tickets.

5. Entry to UN premises on 24th September, at the day of the event for the SDG Moment:

Due to security restrictions for the High-Level week of the General Assembly, access to the United Nations Headquarters will be via the checkpoint at the 46th Street and 2nd Avenue and will be screened at the 47th street and 1st avenue entrance.

A valid government issued photo ID together with a name specific special event ticket will be required to enter the United Nations compound. Participants should arrive one hour prior to the start of the event to ensure enough time for the mandatory security screening and to be seated. If a name specific special ticket is needed, please contact decadeofaction@un.org by Tuesday 16 September, (see sections above).

6. Security

Within the United Nations premises, all persons are required to comply with safety and security regulations, as well as the rules and procedures of the organization. Any act that disrupts the normal functioning of the Organization's programmatic activities, such as public displays of any form, including, but not limited to, clothing, banners, placards or other written or visual means, as well as vocal/audio sounds, gatherings, or demonstrations of any kind, including passive, is not allowed.

All individuals present on the United Nations premises are expected to fully cooperate with United Nations security officers at all times. Refusal to comply with applicable regulations may result in temporary detention or removal from or denial of access to the premises in accordance with Section 10 of the United Nations Headquarters Agreement and ST/AI/2019/5, entitled "Authority of United Nations Security Officers".
