Subject: Removal of High-frequency Global Data Assimilation System (GDAS)
Plots from the Climate Prediction Center (CPC) Webpage on or about
December 1, 2022

Pending user feedback, which will end 30 days after this issuance, the
National Centers for Environmental Prediction (NCEP) Climate Prediction
Center (CPC) will discontinue 6-hourly GDAS plots from the seasonal
hurricane outlook related web pages on or about December 1, 2022.

Currently, CPC creates plots of many variables that are output from the
Global Data Assimilation System (GDAS) at 6-hourly intervals. The
plots/images are currently found at
<https://www.cpc.ncep.noaa.gov/products/hurricane/index.shtml> and
https://www.cpc.ncep.noaa.gov/products/Epac_hurr/EP_index.shtml. These
are accessible with links annotated by "6-hour". Additionally, the
webpages show animations of the same figures.
